After further discussion, Councilor Lepsch amended his motion.

An amended motion was made by Councilor Lepsch that Council request that the 2025 guidance will not include a .25% GRT increment starting January 1, 2025.

Councilor Cull offered a friendly amendment to delay the incremental increase to 2027. It was accepted.

A second amended motion was made by Councilor Lepsch, seconded by Councilor Cull, that Council endorse the recommendations for the 2025 budget guidance with the change of delaying a .25% GRT increase until FY2027.

The second amended motion passed with the following vote:
