I have spent my entire career working in public service, including many years working for Colorado Medicaid, where I focused on supporting the effective operation of large public healthcare programs. Through that work, I developed broad experience with the healthcare system and a strong appreciation for how access, funding, and administration affect people's day-to-day lives. Now that I live in Los Alamos, I want to use that experience to serve the local community. I am interested in serving on the Health Council because I want to help residents of Los Alamos County live their lives as healthy as possible and to support efforts that make the healthcare system easier to navigate for individuals and families. I am motivated to help reduce complexity and fragmentation and to contribute thoughtfully to improving health and well-being across the county.

During my tenure, I would like to contribute to the development of the County's social services hub and support efforts to make health and social services more coordinated and accessible for residents. I am particularly interested in helping ensure the hub reflects community needs and functions as a practical, welcoming resource for individuals and families navigating multiple services. Given my background in public-sector healthcare and familiarity with state and federal programs, I would also be interested in exploring whether there are opportunities to identify or pursue state or federal funding that could support the project, if that would be helpful to the County. My goal would be to contribute in a way that is collaborative, realistic, and aligned with local priorities, while helping strengthen the resources available to Los Alamos County residents.

This experience has given me a strong understanding of the American healthcare system, particularly how public programs support individuals and families in need and how policy and funding decisions affect access at the local level. While my work has been professional rather than volunteer-based, it is directly relevant to the mission of the Health Council and has been grounded in serving communities and improving health outcomes for those who rely most on public services.
