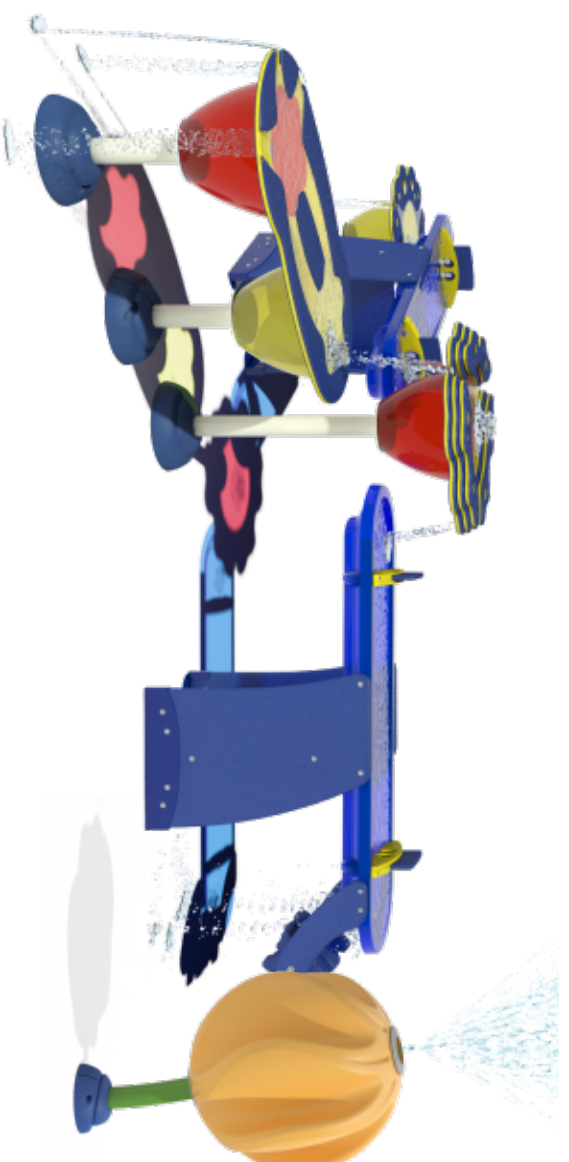
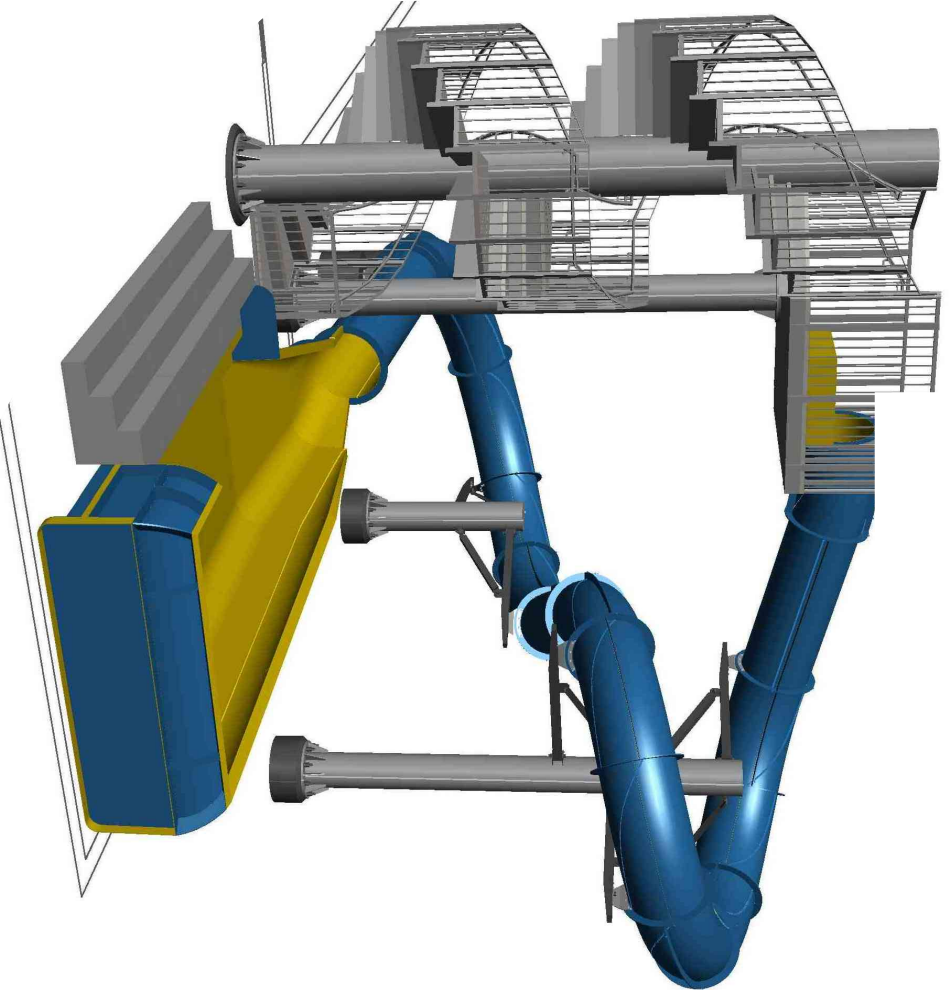
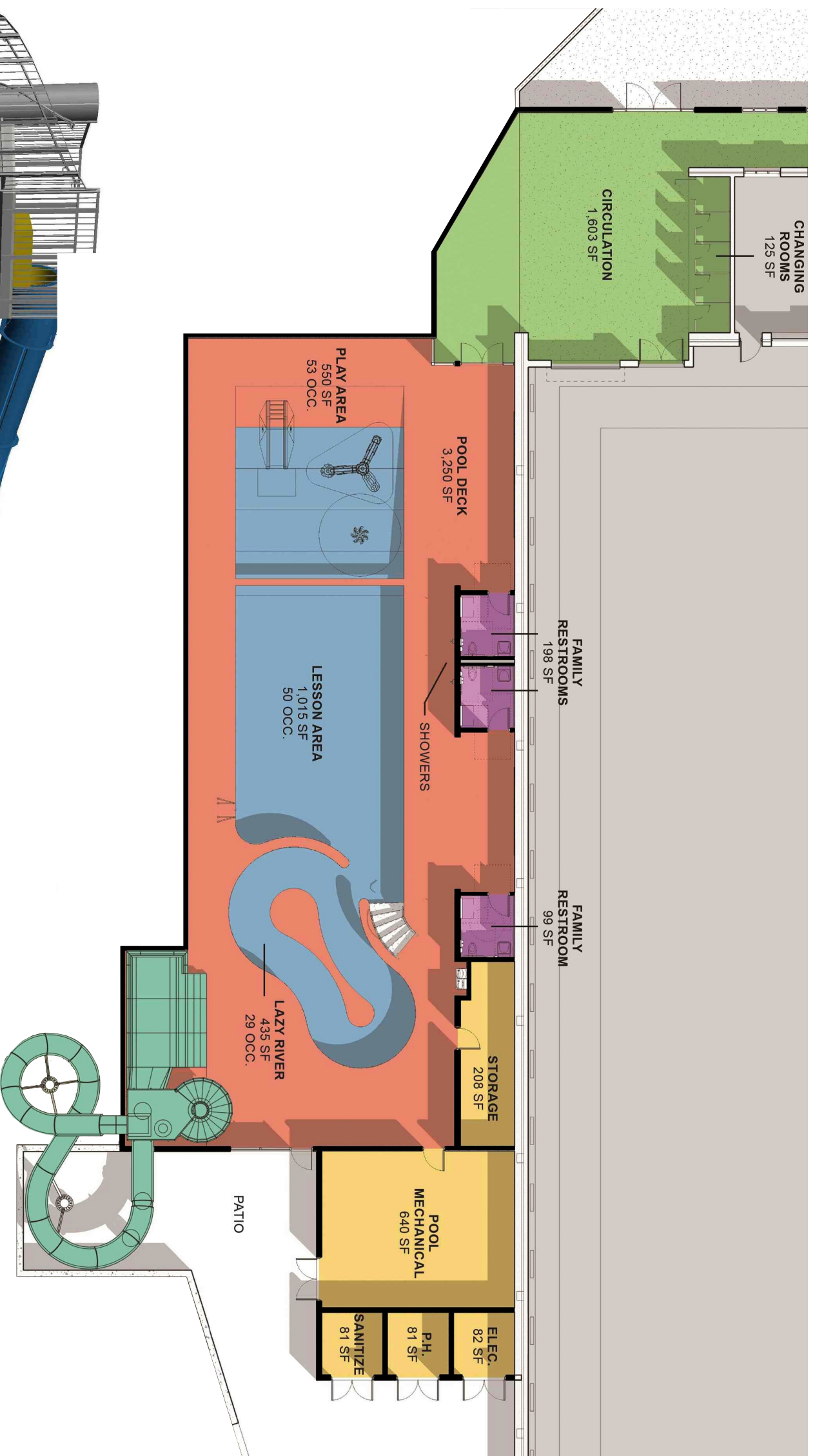


## A1 SITE PLAN

## PROGRAM ELEMENTS

100 SF zero-entry pool, with spray features, lazy river, and an area for swim lessons.

- tower slide with run-out area separate from main pool.

- family changing rooms

- pool support space: including mechanical, chemical storage, and electrical rooms.

- total project budget: \$6.5 million

- construction is slated to begin in May 2020 and last for a year.
