I have been living and serving in this community for over 10 years. I was the past Director of Lifespan Religious Education at the Unitarian Church of Los Alamos. I now serve as the Minister at the Unitarian Church of Los Alamos.

I have a passion for co-creating and collaborating with people across the spectrum of economic classes, perspectives, experiences and cultures in helping us co-create communities that are more inclusive and equitable for all. This is the community we strive to create in the religious context I serve and I have also been part of community initiatives and organizations that work towards multiculturalism and inclusivity for our wider community.

My background is in interfaith education, values-based education, LGBTQ+ inclusion work, justice education, child & youth development/ education, psychology, celebrating multiculturalism & diversity, and anti-oppression/anti-racism education and justice. I have a Bachelor's degree in Religion and Psychology. I have a Master of Divinity degree from Princeton Theological Seminary.

I was part of the group that started the first ever Los Alamos Pride in 2018. I still currently serve on the Board of Friends of Los Alamos Pride and continue to be involved in organizing our Annual Pride Festival and our Annual Los Alamos County Pride Week! I also continue to promote Queer friendly events and spaces in our community throughout the year through the Friends of Los Alamos Pride Board.

I was also part of the Racial Justice Action Advisory Council that started during the pandemic after all the demonstrations at Ashley Pond following the murder of George Floyd. I was able to be a mentor and helper for the youth of our community that were wanting to organize these demonstrations and was invited by the youth to speak at one of these demonstrations.

The Racial Justice Action Advisory Council was a big part of getting the county to make a public statement that Black Lives Matter and a commitment to create the Racial Equity and Inclusivity Task Force. I did not serve on this task force as I was living in Oregon for a year, but I remained involved when I could. I actually was part of the team that

created the charter for the REI Task Force alongside two of our county councilors and two other members of the Racial Justice Action Advisory Council. I wanted to make sure that youth, and especially youth of color, were encouraged to apply to serve on this task force, because their voices are so important to listen to. I got our charter team to add the line, "youth are encouraged to apply", as we advertised this task force out to the community soliciting letters of interest. Unfortunately, I was VERY disappointed when a youth of color did apply and then was not voted on by the majority of our county councilors to serve on the REI Task Force. We still have lots of work to do as a community when it comes to true inclusivity and what that means, and I include myself as someone who also has lots of work and learning to do as well. I think we all can work collaboratively on these issues. Civil discourse is also something that we can work. Being able to have conversations and actually listen to people across lines of division is very important! I am committed to the work of more inclusion and less division!

In 2017 on March 8, I also organized the International Women's Day gathering at Ashley Pond and organized women speakers from all different

backgrounds, professions, and cultures.

I am interested to engage with more of the community on the topic of inclusivity and what that actually means for folks here and as we are situated in the wider Northern NM region. I think we really need to listen to the indigenous voices of our region and county. I have heard ideas from indigenous folks here in our community that it would be great if Los Alamos County had an Indigenous Center just like Santa Fe has the Indigenous Center of Santa Fe. I have heard other ideas of actually educating people on the indigenous names of the mountains that surround us here in our county. These names could then be added to the maps at PEEC nature center and other county maps. Expanding our scope of inclusion is so important!

We are fortunate to be situated in such a rich area of culture and history. Inclusion work is important as we honor the past ancestors of this land and as we look to the future of how we can truly be inclusive and

equitable for all.

As a totally blind Hispanic woman, I have found myself throughout the years exploring the many facets of diversity issues by necessity. In the '70's my family successfully advocated for my inclusion in the Los Alamos school system before mainstreaming laws were enacted. Since that time, I have realized the challenge and joy of my struggle to be invited to join the mainstream and my fervent goal is to advocate for marginalized populations to have a voice. It would be an honor to contribute my skills to the Los Alamos Inclusivity Task Force.

Before retirement I was employed at Los Alamos National Laboratory where I coordinated employee benefits programs in work/life diversity. While at LANL I organized annual disability employment awareness events from exhibits to executive luncheons to information fairs. As an employed mother of three, I was interested in learning about the unique needs of working parents as well as the caregivers who support them. I delivered a workshop to a statewide audience entitled "Work and Family: a diversity issue?" I provided entry-level coursework at the university level to entering child care workers and presented workshops for this population including Parents and Providers in Partnership, which focused on building the parent/caregiver relationship; and Minding Your Own Business, which provided technical assistance for home-based professional child care.

In addition to parenting and work activity, I have had the opportunity to serve in leadership roles in numerous Los Alamos not-for profit organizations including Family Strengths Network, and Self Help.

Today as a happily retired grandma of six, I continue to seek opportunities to serve and to learn from my community. I serve on Los Alamos County's transportation board, where I have presented training to County staff entitled "A Bus for Us: Accessible Transit for Blind and Visually Impaired Customers.", I also provide braille instruction to children in the Los Alamos Public School system, I continue my work as a Court Appointed Special Advocate (CASA) through New Mexico's First Judicial District serving foster children. As a CASA I am the child's voice to the court, so it is important that I work closely with resource parents, social workers, therapists, attorneys and educators to ensure that no child languishes in the system and that they receive needed support services that they may thrive despite adversity.

In conclusion, if selected to serve on the Inclusivity Task Force, I would commit to learning even more about underserved sectors in our community as well as to contributing enthusiasm and creativity in support of our County's efforts to invite all residents to experience the wonders of Los Alamos and its people.

Dear Council Members,

I would like to express my interest in being appointed to the Inclusivity Task Force. I am a white cis-het female in my forties. I was raised in a predominantly white community that was otherwise quite diverse due to its high concentration of military families. I attended college under similar circumstances. After doing masters work in math and obtaining my MA in teaching, I went on to teach high school Math in Chicago. My students were 80% Hispanic (mostly first and second generation Mexican) and 20% Black. All of them qualified for free lunch.

I moved to Los Alamos 14 years ago and have lived here since then except for a year-long "change-of-station" in Seattle. Five years ago with the help of some amazing women, I opened Los Alamos STEAM Lab, an educational space dedicated to tinkering and dabbling. From our opening, a very clear part of our mission was that we would provide an inclusive environment for all people. I think we've come close to that, although there is always work to be done. We serve a very diverse population including kids and adults who are disabled, ethnic minorities, neurodiverse, LGBTQ, and intersectional across all of those groups. Many of these families found us after feeling unwelcome in other spaces.

In Los Alamos, I was the board president of Family Strengths Network. As an owner of Los Alamos STEAM Lab I have worked with the Juvenile Justice Advisory Board, Los Alamos Public Library, and Teen Center. In both of these capacities, I have worked with community stakeholders to target needs in the community and find solutions. I've been happy to start and advocate for new programs, but I've also been content to strengthen and amplify existing programs. I have always been more interested in the best outcome rather than getting credit for the work.

During my life I have lived in eight different communities and have friends in many more. I am constantly engaging in community discourse and trying to find good solutions to known problems as well as bring unknown problems to light. In Los Alamos, I like to be aware of the work going on in town and am often approached by friends who need solutions, not because I have the solutions, but because I can often put them in touch with the people who do. I believe that I can serve as that bridge when turning to other community models to seek solutions to problems of inclusivity, known and unknown, in Los Alamos.

I served on the REI Task Force four years ago. I worked with the Health Council to expand my

understanding of data analysis and surveying into the social sciences. I spoke with JJAB, First Born, mental health practitioners, county employees, and other small groups to understand the needs of the community. Even at that time we spoke of creating a broader 'inclusivity' board that would serve as a keeper of knowledge, best practices, and successful ventures with the idea that that board would work closely with other county boards and agencies to make small changes with big impacts on creating a more welcoming town for our diverse population.

As the council knows, I apply to this task force out of protest. Not because I don't think the work is very important, but because I expended much labor as a member of the last task force and saw little impact. I do, however, think this work is much needed, and after listening to several council members I hope that this time the work of the task force will be taken seriously. Thus, I am inclined to apply again.

I have been working on diversity, inclusivity, accessibility and justice issues within the Unitarian Universalist Association since 1994 when I was elected President of the local Unitarian Church and worked as the church's administrative assistant.


A group of Asian Pacific Unitarian Universalists organized for the first time in 2004 and founded the Asian Pacific Islander Unitarian Universalist (APIUU) chapter of the Diverse and Revolutionary Unitarian Universalist Multicultural Ministry (DRUUMM), of which I'm still a member. In that capacity, I was a founding member, have been on the Steering Committee for several years, the Newsletter editor (the newsletter was named Hot Rice) for three years, and sat on a panel of consultants for the development of the anti-racist, multi-ethnic, multi-cultural curriculum called "Building the World We Dream About". This curriculum is being used in many UU churches for their anti-racism workshops. I was also interviewed and contributed materials to the publication of "The Arc of the Universe is Long — Unitarian Universalist, Anti-Racism and the Journey from Calgary" published by Skinner House Books, 2009. In the capacity of leadership, I led the local Unitarian Church towards becoming certified as a Welcoming Congregation, in addition to being an Accessible Congregation and a Justice-seeking congregation.

Inclusivity takes many forms – gender equality, accessibility for all, anti-ageism, anti-racism, LGBTQ rights, economic justice, and climate justice. To all these issues, I have played a part in different venues. During the height of Covid in 2020, I joined our local Racial-Justice-Advisory Council. We had an email list, and we held monthly meetings on Zoom. I identified a group of about 20 individuals in our community who self-identifies as a person of color, and organized them into a sub-group (BIPOC) within this group. We also held monthly Zoom meetings and reported to the larger group. I created the BIPOC Facebook group where we

further shared our personal experiences, worked towards racial justice, and shared uplifting articles and other resources.

I believe I'm in a position to contribute to the work of the Inclusivity Task Force should I be appointed.

One of the memes circulating on the internet has been attributed to me and is often used in our Unitarian Universalist workshops and other settings.
