

**INCORPORATED COUNTY OF LOS ALAMOS RESOLUTION NO. 25-16**

**A RESOLUTION OF SUPPORT FOR COUNTY PARTICIPATION IN THE 2025-2026 NEW MEXICO DEPARTMENT OF TRANSPORTATION LOCAL GOVERNMENTS ROAD FUND, FOR IMPROVEMENTS UNDER THE SCHOOL BUS ROUTE PROGRAM FOR VARIOUS COUNTY ROADS IN LOS ALAMOS COUNTY, NEW MEXICO, PROJECT NO. L500632**

**WHEREAS**, pursuant to NMSA 1978, Sections 67-3-28 and 67-3-28.2, assistance for local road construction and repair is available through the New Mexico Department of Transportation (NMDOT) from the Local Government Road Fund (LGRF) Program; and

**WHEREAS**, the Incorporated County of Los Alamos (County) applied for funding from the LGRF School Bus Route cooperative agreement program for improvements to various County roads in Los Alamos County, New Mexico. The total funding amount (including the 25% County participation) is ONE HUNDRED FORTY-SIX THOUSAND, SEVEN HUNDRED NINETEEN AND NO/100 DOLLARS (\$146,719.00); and

**WHEREAS**, County has agreed with the NMDOT to utilize awarded funds from the LGRF program, for a project in Los Alamos County, known as the North Mesa Pavement Preservation (the "Project"); and

**WHEREAS**, under NMSA 1978, Section 67-3-32 the State Transportation Commission shall give preference to political subdivisions of the State if the subdivision contributes an amount equal to at least twenty-five percent (25%) of the project cost, and agrees to pay all costs which exceed the total funded amount; and

**WHEREAS**, the County Council of the Incorporated County of Los Alamos supports and prioritizes the Project, approves the use of County pavement preservation funds for the Project, agrees to pay all costs which exceed the total funded amount and shall provide twenty-five percent (25%) of the funds for the Project as required under the NMDOT's School Bus Route cooperative agreement program; and

**WHEREAS**, County agrees to maintain the Project constructed with the LGRF funding for the life of the Project.

**NOW, THEREFORE, BE IT RESOLVED** by the County Council of the Incorporated County of Los Alamos that:

**Section 1.** The County Manager of the Incorporated County of Los Alamos is authorized to execute the School Bus Route Cooperative application and agreement for to obtain funds for the Project, Control Number L500632 with the NMDOT for the LGRF Program for fiscal year 2026 for the Project in Los Alamos County, New Mexico. The County Engineer is also authorized to submit additional information as may be required and act as the official representative of the County in this and subsequent related activities, including requesting extensions of time to complete the Project.

**Section 2.** The County Council of the Incorporated County of Los Alamos supports and prioritizes the Project in Los Alamos County, New Mexico, approves the use of County Pavement Preservation funds for the Project, agrees to pay all costs which exceed the total

funded amount and shall provide matching funds for the Project in the amount of THIRTY-SIX THOUSAND, SIX HUNDRED EIGHTY AND NO/100 DOLLARS (\$36,680.00).

**Section 3.** The School Bus Route cooperative agreement program terminates on December 31, 2026, and the Incorporated County of Los Alamos incorporates all of the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.
