3). Parks and Recreation Board - Shannon Blair

Member DeHaven reported that the Los Alamos County Health Council got their Health Council Master Plan approved by Council approved in December and they have started in January by committing to do a couple of things to really be aggressive on making some accomplishments. One of the items is looking at State mandates on overall community health
