AMENDMENT NO. 1 INCORPORATED COUNTY OF LOS ALAMOS SERVICES AGREEMENT NO. 22-931a, 22-931b, 22-931c

This **AMENDMENT NO. 1** ("Amendment") is entered into by and between the **Incorporated County of Los Alamos**, an incorporated county of the State of New Mexico ("County" or "Subscriber"), and **ChargePoint, Inc.**, a Delaware corporation ("Contractor" or "ChargePoint" or "CPI"), collectively (the "Parties"), to be effective for all purposes April 9, 2025.

WHEREAS, County and Contractor entered into Agreement No. AGR22-931a, b, and c, dated May 9, 2022, for the purchase of Charging Stations, Software Services and Support for the Charging Stations and Operation and Maintenance of the stations, (the "Agreement"); and

WHEREAS, County has a need for additional Services and Equipment from Contractor; and

WHEREAS, Section 31-3(b)(4) of County's Code of Ordinances allows procurement of goods, services, or construction items under existing contracts and which have a current contract issued under a cooperative purchasing agreement with another public entity thereof; and

WHEREAS, Contractor is a party to Contract No. 042221-CPI with Sourcewell ("Price Agreement"); Sourcewell is a local government unit, public corporation and public agency pursuant to the Minnesota Constitution and enabling law Minn. Stat. § 123A.21, authorized to establish competitively awarded cooperative purchasing contracts on behalf of participating agencies, which has competitively solicited a Price Agreement for Electric Vehicle Supply Equipment and Related Services which meets the same standard and specifications as the services and equipment needed by County, namely the provision of an additional six (6) level 2 (two) electric vehicle chargers, related software, support, maintenance and operation of the equipment and services (the "Services"); and

WHEREAS, County is a Participating Entity ("PE") of Sourcewell, and as a PE, County has agreed to follow Sourcewell's cooperative procurement processes; and

WHEREAS, County requested a quote from Contractor as provided for in the Price Agreement, and Contractor provided a quote to County that complies with the pricing terms of the Price Agreement; and

WHEREAS, both Parties wish to amend the term of the Agreement and to add the additional equipment as described above; and

WHEREAS, the Board of Public Utilities approved this Amendment at a public meeting held on April 2, 2025; and

WHEREAS, the County Council approved this Amendment at a public meeting held on April 8, 2025; and

NOW, THEREFORE, for good and valuable consideration, County and Contractor agree as follows:

- I. In reference to AGR22-931a, Master Services and Subscription Agreement, Section 9, Term, Renewal, and Termination, Section 9.1, Term of Agreement, is deleted in its enterity and replaced with the following:
- 9.1 Term of Agreement. Contractor acknowledges that New Mexico law prohibits the inclusion of clauses that automatically extend the duration of an agreement unless one party provides notice to terminate it within a specified time (a.k.a. "Automatic Renewals" or "Evergreen Clauses") and any references to such Automatic Renewals or Evergreen Clauses in the Agreement are hereby deleted and all references to the term of the Agreement are hereby deleted and replaced with the following provision: The term of this Agreement shall commence on the Effective Date and shall continue, for Units SN-224415021846 and SN-224415021843, for additional five (5) year extensions, expiring on 5/8/2032, complying with Quote Q-503940-4; and for the six (6) new CP6021 Units being added by this amendment, terms of ten (10) years, consistent with Quote Q-525811-1 and applicable procurement and appropriations laws, unless sooner terminated as provided herein.
 - II. AGR22-931a, Section 9.2 is amended as follows:
- **9.2 CLOUD PLAN TERM**. Each Cloud Plan acquired by Subscriber shall commence as follows: Each Cloud Plan acquired for use with a new Charging Station will commence ninety (90) days from the date the subscription plan is invoiced. Each Subscriber Cloud Plan shall continue for the applicable duration thereof, unless this Agreement is terminated earlier in accordance with its terms.
 - III. AGR22-931a, Section 9.3 (b) is amended for a scrivener's error as follows:
 - **9.3 TERMINATION BY CPI,** paragraph (b), clause (c), is amended to a capital "(C)".
 - IV. AGR22-931a, Section 9.5 is amended for a scrivener's error as follows:
 - **9.5 REFUND OR PAYMENT UPON TERMINATION.** Reference to Section 9.4(i) is amended to "Section 9.4(a)(i)".
 - V. The following new Section 12 is hereby added:

12. COMPENSATION:

- 12.1 Amount of Compensation. Subscriber shall pay compensation for performance of the Services over the life of the Agreement in an amount not to exceed TWO HUNDRED NINETY-FIVE THOUSAND SEVEN HUNDRED SEVENTY-FOUR AND 29/100 DOLLARS (\$295,774.29), which amount does not include applicable New Mexico gross receipts taxes ("NMGRT"). Compensation shall be paid in accordance with the rate schedule set out in Exhibit 7, attached hereto and made a part hereof for all purposes.
- 12.2 Total Not-to-Exceed Compensation Amount. The Parties understand that County can only utilize Contractor's Services, as specified herein, throughout the Term of this Agreement, in a manner that does not surpass the total not-to-exceed compensation amount for Services originally estimated by County and specified in Section 12.1 herein, unless approved by Amendment to this Agreement. Any increase to the not-to-exceed compensation amount provided herein must be authorized by an Amendment to this Agreement. It is the sole responsibility of Contractor to ensure that all work performed does not exceed the not-to-exceed amount

- of this Agreement and any subsequent Amendment. Any work performed under this Agreement by Contractor where the costs exceed the not-to-exceed amount is not a just and lawful debt payable to Contractor.
- **12.3 TAXES:** Contractor shall be solely responsible for timely and correctly billing, collecting and remitting all NMGRT levied on the amounts payable under this Agreement.
- VI. The following new Section 13 is hereby added:
 - **13.** In the event of any conflict between the terms, conditions, and provisions of this Agreement, and the terms, conditions and provisions of any exhibits or attachments, the terms, conditions and provisions of this Amendment shall control and take precedence.
- VII. The original Agreements AGR22-931a, b, and c had Quotation Q-188573 attached, but without a reference. Quotation Q-188573 is hereafter referenced as "Exhibit 1-A".

The Following referenced Quotations are amended as exhibits to the Agreement, as follows:

- VIII. Quotation Q-525811-1 for the purchase of six (6), CP6021 level 2 chargers, concrete mounting templates, Commercial Cloud plan subscription, ChargePoint Assure services for CP6000, and EV Charging station activation is hereby added as Exhibit 4.
 - IX. Quotation Q-525804-1 for Engineering Design Review services associated with the level 2 chargers described above is hereby added as Exhibit 5.
 - X. Quotation Q-503940-4 for the extension of Commercial Cloud plan subscription, and ChargePoint Assure services for CPE250 is hereby added as Exhibit 6.
- XI. Exhibit 7, Compensation Rate Schedule is hereby added.

Except as expressly modified by this Amendment, the terms and conditions of the Agreement remain unchanged and in effect.
