Once a resident fills out and submits this application, an interview is scheduled with the B&C's County Council liaison, the relevant staff liaison, and the B&C Chair. After the interviews, the applicants' names are presented to the full Council during a regularly scheduled Council meeting, where a vote is taken regarding the appointment of each applicant. Each applicant will be notified if they are appointed or not.

Came back to work at the Lab as a mechanical/welding engineer. 4 kids. Knows there's a conflict of interest process to go through, might do that for this, has done it before. Generally has an appreciation for Los Alamos, understanding the culture and the uniqueness of it, how things move, how progress is made. Is excited about the town, is not the same one he grew up with. Likes change and progress. Excited to be a part of it.</p>
