I would be interested in a stables subcommittee. I am not a horse owner. I have goats, sheep a llama, and poultry. My interest in a subcommittee is to have the stable lot renters have a place in the government process similar to that for the golf course and the aquatic center users. My second area of interest is the Community Wildland Fire Project Plan. I am working towards a Master's degree in Agricultural Science from Colorado State University. My master's project paper is on the use of goats to create wildland fire breaks in the southwestern United States.
