## Why are 7% rate increases needed?

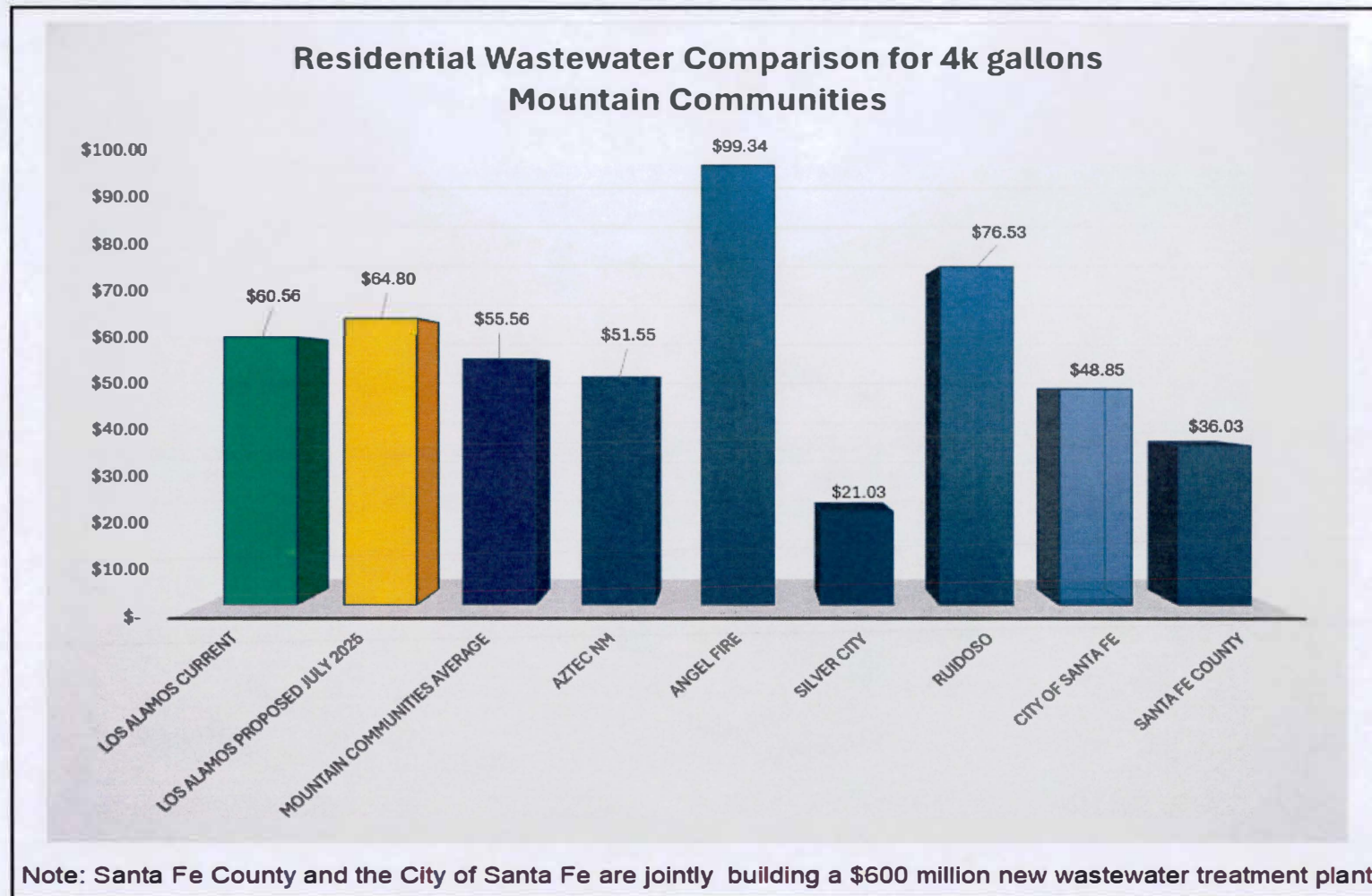
- Maintaining two wastewater treatment plants

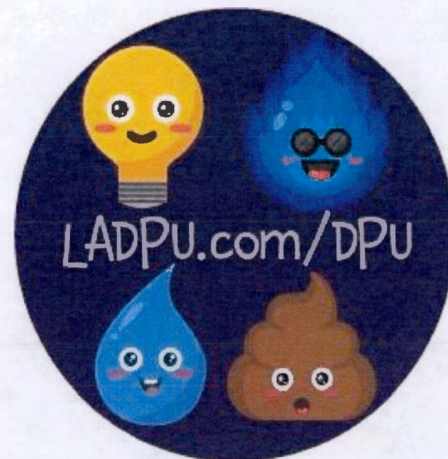
