**NOTICE OF ELECTION BOARD MEMBERS (aka Poll Workers) STANDBY LIST**

Pursuant to NMSA 1-2-9, notice is hereby given that the Los Alamos County Clerk will be appointing Election Board Members (also known as Poll Workers) for the 2022 General Election to be held on Tuesday, November 8, 2022. Appointments will be made for all 23 precincts in Los Alamos County at the following consolidated polling locations (referred to as Vote Centers): Five (5) Election Day Vote Centers: Municipal Building (estimated 11 Precinct Board Members); White Rock Town Hall (estimated 11 Precinct Board Members); LAC Golf Course (estimated 11 Precinct Board Members); Betty Ehart Senior Center (estimated 11 Precinct Board Members); and University of New Mexico-Los Alamos

(estimated 11 Precinct Board Members). Two (2) Early Vote Centers: Municipal Building (estimated 10-30 Precinct Board Members) and White Rock Town Hall (estimated 10-20 Precinct Board Members). One (1) Absentee Board: Municipal Building (estimated 10 Precinct Board Members). We will be conducting this election with in-person voting, while following any COVID Safe Practices (CSP) that are in place at the time of the election.

To serve as a poll worker you must either be registered to vote or be 16 or 17 years of age and have your parents' or guardian's permission. Attendance at a training session is required. The rate of pay ranges from \$62.50 to \$200.00 per day depending on job duties, shift length and shift type. If you are interested in being added to the standby

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE INCORPORATED COUNTY OF LOS ALAMOS, as follows:

**Section 1.** Section 40-171 of the Code of the Incorporated County of Los Alamos is amended to read, as follows:

**Sec. 40-171. Potable water rate schedule 8-A.**

- (a) *Applicability.* Potable water rate schedule 8-A is applicable to all classes of retail customers whether commercial, residential or otherwise. The rate shall consist of a service charge plus a water consumption charge.
- (b) *Service charge.*

**Section 2.** Section 40-173 of the Code of the Incorporated County of Los Alamos is amended to read, as follows:

**Sec. 40-173. Non-potable water rate charge.**

The water consumption rate for non-potable water, including effluent reuse water, shall be \$2.79 \$3.03 per 1,000 gallons for consumption through September 30, 2020 October 31, 2022, \$2.91 \$3.18 per 1,000 gallons for consumption October 1, 2020 November 1, 2022 through September 30, 2021 2023, \$3.34 per 1,000 gallons for consumption October 1, 2023 through September 30, 2024, \$3.51 per 1,000 gallons for consumption October 1, 2024 through September 30, 2025, and \$3.03 \$3.69 per 1,000 gallons for consumption after September 30, 2021 2025.

**Section 3.** Section 40-175 of the Code of the Incorporated County of Los Alamos is amended to read, as follows:

**Sec. 40-175. Bulk delivery rate schedule 8-D.**

(a) *Applicability.* Schedule 8-D is applicable to all bulk water sold and delivered to bulk points of delivery. The rate shall consist of a service charge plus a water consumption charge.

(b) The bulk delivery rate for water sold and delivered to bulk points of delivery shall be \$3.81 \$4.13 per 1,000 gallons for consumption through September 30, 2020 October 31, 2022, \$3.97 \$4.83 per 1,000 gallons for consumption October 1, 2020 November 1, 2022 through September 30, 2021 2023, \$5.07 per 1,000 gallons for consumption October 1, 2023 through September 30, 2024, \$5.32 per 1,000 gallons for consumption October 1, 2024 through September 30, 2025, and \$4.13 \$5.59 per 1,000 gallons for consumption after September 30, 2021 2025.

(c) The customer service charge for water sold and delivered to bulk points of delivery shall be \$718.35 \$778.84 per month per customer for service through September 30, 2020 October 31, 2022, \$748.88 \$817.78 per month per customer for service October 1, 2020 November 1, 2022 through September 30, 2021 2023, \$858.67 per month per customer for service October 1, 2023 through September 30, 2024, \$901.60 per month per customer for service October 1, 2024 through September 30, 2025, and \$778.84 \$946.68 per month per customer for service after September 30, 2021 2025.

**Section 4. Effective Date.** This ordinance shall become effective upon adoption with the amended water rates being applied for all billings on or after October 19, 2022.
