Chelsea Ashcraft and Chair Haaser updated the Board on the Justice Center Wall Art Designs. The survey results were available and discussed by the Board. Chelsea gave a review of what was discussed in the last meeting. The first survey had 170 respondents, and the second survey had 116 respondents. Chelsea explained the process on how the mural would be put together as a community, and what would happen if we were not able to put it all together in the 1-3 days. A temperature of 40F needed for installation.

I move that the Art in Public Places Board select Design #2: "Birds and Big Skies of Los Alamos" by artist J Muzacz, and recommend that County Council approve the purchase of this glass tile mosaic for installation on the south-facing wall of the Justice Center, for a not-to-exceed amount of \$70,000. This amount includes all costs for materials, fabrication, installation, community engagement, plaque, ribbon cutting ceremony and contingency expenses, excluding gross receipts tax (GRT).

The general plan is to choose a winner from the submissions, then have the winning art on display for a while, then an offer to procure the chosen piece would be made by APP. Discussion on the process was had. Questions from the Board were answered.



Q1 How do you feel about Design 1?








