An Open Letter From Fr. Theophan On Leisure Lagoon Art

My tenure as the Chairperson of the Art in Public Places Board (APPB) for Los Alamos County is coming to an end, but I would like to make one plea before I go.

The Parks and Recreation Board came to the APPB a year ago and suggested that we find art to enhance the aesthetics of the Leisure Lagoon, the addition to the Walkup Aquatic Center that is under construction.

Originally, I had found an artist for the outside and the inside of the proposed space, but the exterior proposal would have required a change to the architecture of the building and much expense. The interior piece could be applied to the wall, much

like any other tile, after the construction was complete.

When a piece of art is proposed to the board, after the artist and placement and cost of the work is agreed upon, before it is taken to the county council, we seek public comment.

Two years ago, we proposed a large installation by Evelyn Rosenberg that would have enveloped the new pedestrian tunnel under the road leading out of town. The cost was high, but it would have been integrated into the tunnel itself and been a crowning achievement by a well know artist. The county board decided that it was too far out of town and cost too much.

Last month we reached out to the community for comment on “Boys of Pajarito Plateau” by Jeff Segler. The strong majority of the response was negative. Some due to the subject matter, some due to the artist’s affiliation, and some due to the price. The board listened to the public and withdrew the proposal.

Now we are entertaining another proposal. The price is large: \$100,000. But for its size, by square footage, it is 1/10th the price of the “Boys” painting. Two-hundred square feet of hand-made and hand-painted porcelain is not cheap, but it is permanent. Amanda Jaffe has a similar mural that has remained unchanged outside the Staten Island Zoo, exposed to New York winters, for the past 30 years. She was my ceramics professor 25 years ago, and was creating large tile, water-themed, installations back then. When this space was suggested to the board, I immediately thought of her work.

The argument as to whether or not there should be a public art collection in Los Alamos was settled 20 years ago. The county charter has 1 percent of capital improvement projects allocated for public art and 1.5 percent of road projects, not necessarily to be applied to that specific project.

We also only consider works of art that will last for more than 20 years. If you want the public art to go away, vote on to the county council who will change the charter. Arguing against the APPB in their service won’t get rid of the art, it will only make it harder to find artists willing to work with the county.

When an artist is paid for their work, they are not being paid just for the time and materials that went into that specific piece. They are being paid for their education, for thousands of failures, and hundreds of breakthroughs; for a life-time of commitment to what some vocally deem as worthless.

“Well, I could do that!” as an argument against art, should receive a resounding, “Then why don’t you?” If it is so easy as to be a worthless endeavor, give it a try. Make something that no one has ever made before, and then put it into a public forum where people with no appreciable education or experience can throw verbal manure at it.

“I don’t know art, but I know what I like.” is ignorant and arrogant. Take the time to learn about something before you judge it.

“All opinions are not equal. Some are a very great deal more robust, sophisticated and well supported in logic and argument than others.”

We on the APP board go out of our way to work with local artists, and if there is a local artist who wants to work with the county and our board, we welcome them as



Katherine gave an update on the RFP Process. The RFP for an agreement to maintain the Los Alamos County Art Collection has expired; it ran for a month. The RFP did not receive any responses. A new RFP is being issued and will be readvertised for another month. At the July 2021 Board meeting Staff Liaison, Katherine Hudspeth gave an update that the RFP was again met with no responses. She is working with procurement with a path forward, to identify if the potential budget is too small for what is being asked. Los Alamos County issued an RFI (Request for Information) on Oct. 15, 2021, it is scheduled to run until Nov. 2, 2021. The purpose of the RFI is to gather information from subject matter experts to improve and refine the scope of work prior to reissuing another RFP.

On November 10, 2021, Katherine Hudspeth met with Los Alamos County Procurement to discuss the results for the RFI's. Which demonstrated:

- An initial assessment should be included within the first year of the contract, to properly assess the condition and plans forward for the collection, and each piece within the collection.
- Documentation of the maintenance with narrative and before and after pics to be included after each maintenance period with invoice should be included.
- A multi-source contract is not favored, and when developing the RFP, the County should request that respondents be able to perform work on all materials present within the outdoor collection.
- Some respondents provided estimates, based on the outdoor collection list and current maintenance schedule provided. Based on those estimates and estimated work required, a seven year contract could cost between \$180,000 - 250,000.

Body

Member Mackey is the lead for this project. Steve Huebner updated the board at the Oct. 22nd meeting, stating that the Kiddie Pool construction is scheduled to begin on Feb. 2021 and be completed in Feb. 2022. As the project manager, Steve expressed that if APP is going to consider putting art in this location, that a firm design would be needed by Aug. 2021. Initial ideas from the board were a mural, a mosaic of tile or other material, Ceramic art such as fish, similar to the kites in the White Rock Library, and Sea Creatures. Board is to brainstorm ideas for this project with additional information of materials recommended for an enclosed aquatic center environment. At the Dec. 17, 2020 meeting Member Mackey presented two potential artists for the interior, Amanda Jaffe, and, Collette Marie for the exterior of the building. Member Mackey was tasked with further discussing with these artists further details and rough estimate costs for potential art.

At the Jan 2021 meeting Member Mackey provided addition details of the proposed pieces. The Exterior would be a concrete formed lined piece, proposed to be placed above the new windows of the pool. The Interior is proposed to have 5 pieces, each sitting underneath the new windows of the pool, and would need to be sunk at least 2 inches into the wall. Both proposals need extreme coordination with the project manager, Steve Huebner for feasibility in construction timeline and contractor capability an scope. Staff Liaison, Katherine Hudspeth, reached out to Steve Huebner with a summary of Jan. 2021 discussion, asking several questions, Member Mackey was cc'd.

At the Feb. 2021 meeting New Chair Mackey provided additional details. The exterior of the Aquatic Center will be concrete block, not form-lined, as previously through, therefore the stamped concrete is not a viable idea. Further research needs to be done for any exterior ideas. As for the interior, Amanda Jaffe is excited for the potential project, and does need to figure out how the pieces would be mounted, since they can't be sunk into the wall. She going to send samples, Attn: Katherine at the Muni Bldg., and does plan to use thick tiles (2in), would use 2in angle iron and adhesive to mount.

Safety concerns were brought up at the June 2021 by county staff, and the board was asked to consider other ideas for art for the facility. Chair Mackey requested a meeting with the CSD Director to discuss. Chair Mackey was to gather additional information from the artist before any additional action was taken. Through January 2021 - October 2021 details regarding potential pieces were discussed with the artist, and safety concerns discussed and address with the

Leisure Lagoon Project Manager, Wayne Kohlrust.

The 5 ceramic mosaic pieces are as follows:

- Clay used for the murals will be non-porous.
- The mosaic murals will be composed of tiles that are solid and approximately 6" square.
- Center mural ceramic tiles will be less than ¼ inches thick
- The surrounding boarder will be slightly less than 3/8 inches thick.
- Total mural size 7.7 feet x 5.5 feet each
- Each ceramic mural would weight approximately 138 lbs.
- The back of the ceramic tiles will have small, raised lines (just like a commercial tile) to hold the commercial grade adhesive; the tiles of the mural will be attached to the wall, by a professional using only commercial grade adhesive.

Ceramic tiles have been proven to last the elements of an aquatic center and are routinely used during pool installations. The proposed mosaic murals are to represent water in other forms, snow, ice, and rain. The artist has used a repeating pattern and flowing line to give the sense of the quiet effect water can have. The artist believes the colors selected, as seen in the attached picture, are bright and playful colors, that project a sense of joy, given that the space is geared toward children.

A public comment survey was conducted October 8 - 28, 2021 via Survey Monkey. Additional comments were collected from the Community Services Facebook Page, The Los Alamos Daily Post Facebook Page, and a letter written to the Los Alamos Daily Post, also attached. In response to the initial letter written to the LA Daily Post, APP Board Chair, Theophan Mackey wrote a response letter, and additional comments were collected from that. This letter is also attached.

Overall the survey showed that respondents were supportive of the proposed art, except for the cost. However, there were many comments noted that different mediums and colors were desired for the given space. Given this information, the APP Board approved to move forward with this recommendation.

The timeline for completion of the murals is estimated to be two (2) years, following a signed contract. The mosaic murals will be delivered and installed as they are completed.

Amanda Jaffee is ceramic tile artist and Professor Emeritus, where she taught ceramics from 1985 - 2011 at New Mexico State University, and is located in Las Cruces, NM. Her relief porcelain wall tiles are frequently abstract with landscape references and living close to the US southern border has brought Mexican cultural influence into her work. Experiences swimming in the ocean and pools makes important contributions to Amanda's imagery. High relief ceramic tile wall pieces have been Amanda's primary focus but in 2008 she returned to a sculptural format. The scale of her work ranges from very small to public murals. She has completed three large public art projects in Texas, Washington state and at the Staten Island Zoo for which she received a New York City Art Commission Design award. In 2011 a retrospective exhibition of her art: Looking Back, "Looking Forward" was shown at New Mexico State University.

Cleaning of the murals would be the same of any ceramic tiled wall, therefore an additional maintenance/cleaning cost should be avoided.

The recommendation for the 5 mosaic tile pieces was taken before County Council on Nov. 16,

The Sunflower donation, restoration and installation was approved by County Council on Sept. 29th, and the Formal Donation Acceptance form was completed Oct. 21, 2020. Sunflower is in possession of Los Alamos County, and Katherine is working with Steve Huebner and Procurement to establish an RFP for the work needed to be done. On April 2nd, Katherine met with Steve Huebner and now has the draft RFP in her possession. Edits will be made to align with the scope of the project and will then be sent to procurement for review, and then to legal. As of June 7th, the RFP for the Sunflower project is ready to be advertised, however Public Works would like to wait a month so that this project can be assigned to Steve's replacement. Therefore, this project is on hold until around July 7th. Steve's replacement, Sarah, started with the County in late September, Katherine will be working with her to get the project resumed. Katherine met with the new Project Manager, Sara Rhoton. They are in agreement that the RFP is close to being complete. When the RFP is sent out, it will run for a month, and a member of the board will need to participate in the evaluation committee.
