1. Preparation for presentation of CHP work plan to the LA County Council (Phil/All):

The CHP work plan is schedule to be presented before the County Council on December 16, 2021 along with the request for budget authority to use the funding from the Kellogg Foundation. There were suggestions for standardizing format throughout the slide presentation and adding the LA-Social Services logo. Richard and Rachel will review the current draft and suggest revisions for consideration.

2. Suggestions for information to include on the 100% Los Alamos website (All):

A question was raised regarding the objective or objectives of the 100% Los Alamos website. It was decided that the Sub-Committee needed more information about the purpose of the website and whether the website can be customized to better meet LAC's needs. Katherine and Cam will contact the sponsors of the website (100% New Mexico) and get further clarification.

3. Comparative analysis of health plans in similar locales (Richard): After reviewing the list of comparable sites compiled by his research assistant, Richard felt that the locations were overly weighted toward rural locations that were too dissimilar to Los Alamos. Richard does see value in reviewing the listed sites for their experience with hospital closings and issues with providing adequate mental health services. He will ask his research assistant to redo the search using the Census Bureau definition of micropolitan areas as the primary inclusion criterion.

## 4. Additional agenda items? (All):

(1)This is the last CHP Sub-Committee meeting that Donna will attend prior to her leaving employment with Los Alamos County. Katherine Hudspeth will be serving as the LAC liaison until further notice. (2) Deni Fell, also of LAC Social Services will be participating in the CHP Sub-Committee. (3) Donna noted that the CHP Sub-Committee has been formally designated to serve as LAC's Health Equity Committee as required as a condition of accepting the Kellogg Foundation Grant. (4) A question was raised about the role of major employer healthcare contracting as a potential barrier to full access to healthcare. The topic will be included in the assessment of the level of access to healthcare services in LAC. (5) Donna noted that the contractor that prepared the Gap Analysis was able to get hospital service utilization data. (6) Donna noted that the required Health Equity Committee training occurs on the 1<sup>st</sup> and 3<sup>rd</sup> Mondays of each month. Although all Health Equity Committee members (i.e., CHP Sub-Committee members) are welcome to participate in the trainings, Cam and Katherine will be responsible for representing the LAC Health Equity Committee.

5. Next steps (Cam):

It was noted that following approval of the CHP work plan by the LAC Council, the CHP Sub-Committee members can expect that we will begin to develop a detailed work plan. The will include specific tasks, assignments, and timelines.

## Updates/Needs

LA Cares – Last distribution assisted fifty-nine families and included twenty-four deliveries. December distribution will include fruit bags donated by the AAUW, household items, and a special holiday meat item. Freezer space continues to be an issue so hoping to find others that can store the meat items or purchase them right before the distribution on December 9<sup>th</sup> and 10<sup>th</sup>. LA Cares is looking for volunteers to assist with deliveries.

First Born – Serving their funding maximum of seventy-five families and currently have a wait list. Seeing issues with women being able to get an appointment for OB/GYN care in Los Alamos. Families continue to struggle with mental health care. Also, seeing issues related to holiday stress and looking to partner with LAFD to adopt families needing assistance.

Social Services – Have Food Depot distribution flyers available for organizations. Donna Casados, Social Services Manager will be leaving employment with the County on December 10<sup>th</sup>. Katherine Hudspeth has been named as Interim Social Services Manager and recruitment to fill the position is under way.

JJAB – Resource Specialist Christine Martinez helped to organize a successful event for Spanish-speaking parents. The event included 25 participants and a range of topics including mental health, school resources, LGTBQ+, and family challenges. JJAB partnered with First Born and Los Alamos Family Council to provide the workshop. Had ninety-four requests to provide youth with winter clothing and the project is currently in distribution phase. JJAB is hosting a discussion with multiple organizations about the current levels of substance use among middle and high school youth and in the community.

The Food Depot – Due to the holidays, the mobile food pantry distribution dates for Los Alamos have changed to November 19<sup>th</sup> and December 17<sup>th</sup>. Normally have two hundred cars for the distribution, however most of the people receiving food live outside of Los Alamos County.

## **County Health Council Update**

Lisa Zuhn provided an update that the CHC work group is continuing to discuss options for a comprehensive Community Health Plan.

#### **Discussion**

The group had a discussion on families with long-term basic needs - identifying the root cause, providing families with long-term solutions, and assisting families in releasing from the cycle. Highlights from the discussion were:

Need someone form Human Services Department to be a part of the Basic Needs Committee to ensure we are making connections with them about long-term resources (SNAP, Medicaid, State Services). Barriers identified were access to internet to apply for benefits, inability to complete paperwork or provide data, documentation required, overwhelmed by the process, and the State is lacking staff there for not providing in person hours in Los Alamos. It was also discussed

that many programs rely on income as the deciding factor but do not look at debt to income ratio. Providing face to face, individual assistance is particularly important and works well for assistance.

LA Cares indicated that Human Services could come to their distribution events to provide information and assist people with completing paperwork. It would take them being there a couple of times for people to feel comfortable with the process.

Deni indicated that LifeLink in Santa Fe is also a valuable resource, and they did a presentation at the Youth Resiliency Committee meeting.

The group discussed the option of providing career possibilities to adults within the community. For example, certification for Community Health Worker or Peer Support Worker. SFCC and CNM currently offer classes, could it be possible for UNMLA to provide? The certification can provide opportunities in the medical field and could also provide case worker options within the County. Barriers for people wanting to receive additional education are, childcare needs, need to continue working while in school, and loss of some benefits if income increases yet do not make enough for cost of living. The Early Childhood Education Department does have some grants if programs are related to early childhood programs.

One suggestion provided was to create a "roadmap" for long-term resources based on available and the ability to provide stability.

The discussion will continue at the next sub-committee meeting that will be scheduled for mid-January.

An excellent intergenerational opportunity for adults to host game tables – bring your own or choose from 400 available games. Contact Melissa at <u>mj.mackey@lacnm.us</u> to sign up. Hot chocolate and cookies will be served. They are also planning an event in coordination with the Senior Center to learn and play card games.

Key Clubbers will be helping out at Trinity on the Hill Church's Children's Bazaar on December 4th where kids can shop for inexpensive holiday gifts. The annual Santa event will take place at the Catholic Church Parish Hall – no breakfast this year but an opportunity to take photos with Santa.

FSN is hosting a Sensory Friendly Holiday event on December 14<sup>th</sup> from 5-7 pm for children with developmental disabilities or who are challenged by larger group activities.

The Los Alamos Teen Center is planning to host de-stress activities for teens in preparation for the end of semester and finals week – epic nachos, henna, puppies and kittens.....

The Family Y Wellness Department is planning a Jingle Bell Predict Your Time Walk/Jog for December 11<sup>th</sup>. The Middle School Fitness and Fun class series has been a success with funding support from JJAB and in response to a recognized need and community request. 8 teens have the opportunity to work with a personal trainer to learn technique and set goals, try out Y classes, and participate in the Cooperative Extension's Teen Cuisine class.

Los Alamos Family Council is moving to a new location at 1350 Central Avenue and will be hosting a 60<sup>th</sup> anniversary celebration open house from 5-8 pm on November 30<sup>th</sup>.

## **Resilience Discussion –**

Lara Yoder from <u>the Life Link</u> presented re: vital housing resources and related services for Los Alamos County and surrounding northern county residents. The Life Link also provides behavioral health services, substance abuse counseling, and case management. Staff are trained to see and work with the family as a whole and in mental health and trauma-informed care.

Lara described in detail the different housing support programs and requirements for clients to be eligible. These are last resort options for clients who have exhausted other local sources of support to either keep them housed or get them into housing. Depending on the funding source, the support may be offered to prevent eviction; to help pay back rent and utilities and some portion of rent for a period of time; to help people who are working but are experiencing homelessness; to help families move into a home and back on their feet including assisting with deposits, rent and utilities; to help people who have a disability and are homeless or precariously housed. The Life Link staff are able to help determine which funding is the best fit and also assist clients with applying for other sources of support. Los Alamos County related resources include Los Alamos County Social Services Department, Self Help, Inc., LA Cares, and local churches.

- Help break stigma of asking for help by educating community members about the resources and their qualification guidelines

- Host a community meeting to inform landlords and recruit them as partners
- Assure the court staff have resource lists to offer people at risk of eviction
