Member Lueninghoener is continuing to meet with the Community Health Committee and members of the community for collaborative efforts in gathering data that will be needed for the Community Wellness Survey that will be seen through a Racial Equity and Inclusivity Lens. Vice-Chair proposed to include systems to the survey working group.

#### B. Communication Working Group (Green, Naughton, Lueninghoener)

#### C. Public Outreach Working Group (Green and Holtkamp)

Chair Green updates and Member Holtkamp updates that there are ongoing efforts with reaching out to other committees to for outreach research. Chair Green announced plans for a possible BIPOC Caucus focus group meeting in the works. Chair Green wants collaborate with the Teen Center to gather data from youth ages 12 to 18 in the community on their personal/ educational experiences with equity and racism. Collaborations with the teen center continue with creating a survey to gather data from that age group.

Art in Public Places was included in the Public Outreach working group- Member Lueninghoener announced that she met with the Art in Public Places Board and reported the art selection process is to prioritize local artists before other artworks. Art is selected by the amount of years it is guaranteed to last. The Art in Public Spaces Board asked the Task Force with assistance to submit a proposal to diversify art in the community.

#### D Youth Outreach Working Group (Lueninghoener)

Member Lueninghoener is moving forward with inviting youth to lead the working group and adults to join as well. Collaborative efforts continue with invitations extending to First Borne, youth services from the library, JJAB's Restorative Justice Program, Indigenous Youth Programs, and Teen Center. Task Force will oversee and guide goals, objectives, and tasks for the youth lead working group.

Member Adams updated his attendance to the LA schools Equity Task Force and will continue to update as information becomes available.
