




Public Relations

Since the last report, SUNNY505 has distributed a release on White Rock being named the Happiest Small Town in the U.S. and a news release promoting National Park Week vacations.

The White Rock news release received coverage in the Associated Press, Budget Travel, Boston Herald, News OK, Pittsburgh Post-Gazette, and the International Business Times, among many other national outlets. In addition to national coverage, the White Rock release also received local coverage on KRQE and in the Los Alamos Daily Post. The National Park Week release has received local coverage in the Los Alamos Reporter and Los Alamos Daily Post. Pitches are ongoing.

<u>Other</u>

We submitted a cooperative advertising grant with the New Mexico Tourism Department. The amount of the grant is \$272,646. If fully funded, the amount Los Alamos County will owe is \$90,882. We negotiated an Oppenheimer-focused advertorial with New Mexico Magazine. We also produced an ad in the program for both the Texas Rangers and the Arizona Diamondbacks baseball season. Each ad has a unique QR code that will be tracked to see engagement and results.

February Narrative Comments:

- The new Los Alamos Adventure Guide's has been delivered to DLA's storage unit. Santa Fe Brochure Distribution picked up 50 boxes. There are approximately 16,000 copies of the guides available in storage.
- Event material in kiosks and the displays are updated weekly or as needed by a DLA representative. These contain a weekly Concierge Calendar and are restocked with 8-10 different Los Alamos County tourism pamphlets. There are currently <u>25</u> in place in the Los Alamos, LANL and White Rock areas.
- All state-managed visitor centers were contacted during the month to ensure they have Los Alamos Adventure Guides in stock. Similarly, local distribution points are also monitored. These are filled by our contractor Brochure Distribution out of Santa Fe.
- DLA's website www.visitlosalamos.org and events info feeding www.fyilosalamos.com are updated on a weekly basis with events and information.
- DLA recruits, trains, and manages volunteers for a variety of work. There were **<u>8</u>** volunteer hours logged for the month of February.
- WRVC Business Display Cases featured the Nature Center (PEEC), Gadgets (Bradbury Science Museum), Los Alamos History Museum, Bathtub Row Brewing Coop, Los Alamos Coop Market, Cricket Window, Little Studio on the Mesa, Brenda Fleming (local artist), Metzger's and Samizdat Bookstore were on display for the month of February. The large display featured the Bradbury Science Museum.
- In February, DLA helped the following groups/events requesting assistance in promoting and planning their upcoming planned and/or potential events in 2024. We provide tourism materials and information as needed for each group.
