Manhattan Project Sign

- Sign was struck by a vehicle or equipment in early December 2023. Staff is not sure how the damage occurred.
- LAPD removed the sign and stored it until the Parks Division retrieved the sign.
- Parks attempted to repair the sign and due to the bend, is unable to make the repair.
- The sign is bent which will require a sign company to repair, if possible. It may be too damaged for repairs.

Sign Placement Option #1

Placement marker is indicated in blue.

This is our first choice for placement. Visitors can view the plaque while viewing Fuller Lodge and the statues. This location is suitable for wheelchair accessibility and may allow for the sign to be placed at the correct height (40-60" high – 40" off the ground).



Sign Placement Option #2

Placement marker is indicated in blue.

This is our second choice for placement.

Still a nice viewing area of the lodge and statues.



Sign Placement Option #3

Placement marker is indicated in blue.

The placement would be between the two statues, which would take away from the ambiance.

<u>Los Alamos County Community Services Department Erin Tatge</u> Artist connections: Mr. Sandoval is a Los Alamos resident. Mr. Segler is a local artist located in Santa Fe, and is the National Artist for the Boys Scouts of America.

The Art in Places Board is responsible for recommending to Council the acquisition and maintenance of all works of art in the Los Alamos County Public Art Collection. There are approx. 172 pieces within the collection. $\cdot 2w$

- Erin Tatge Is there a more specific scope to "all works of art?" For example, is there supposed to be a focus on diverse art, local artists, art reflective of the community, art appropriate to a specific display location, or just art somebody likes? It seems like this survey can't get a lot out of the results other than "does the respondent like it?" Including purchase price with no context isn't helpful.



Q1 Do you support APP making a recommendation to remove "Trail to Santa Fe" from the Art In Public Places Collection?




