Greg Robertson presented his proposal for the Community Garden Solar Water Fountain and answered questions from the board. Board Members discussed the art pieces presented by Robertson. Emmanuel Abeyta from the Parks Department gave information on the water source available at the garden. A drip irrigation line is what is the available water source. The artist discussed how the fountain would connect to the water source and placement of the solar panel. Eric Brown presented his proposal for the Community Garden Solar Water Fountain and answered questions from the board. His proposal is called, "The Oasis". The proposal for "The Oasis" is the hand drawn picture and the sculpture will be all clay. Eric answered question from Emmanuel Abeyta from Parks on how it would be mounted down and explained how the pump would be protected from sediment. Public comment would be the next steps. Member Ozment will get public comment on the art proposed. Discussion was had on what art from the proposals and scale should be presented for public comment. Discussion was had on the date the fountain should be installed. Options for avenues for surveys was discussed. Survey will be put out for 14 days.

Kiddie Pool Project and Potential Art

### **Recommended Action**

**I move that the APP board move forward with selecting an artist and developing art ideas for the space identified in the new kiddie/leisure pool space at the Aquatic Center.**

### **Body**

Member Mackey is the lead for this project. Steve Huebner updated the board at the Oct. 22nd meeting, stating that the Kiddie Pool construction is scheduled to begin on Feb. 2021 and be completed in Feb. 2022. As the project manager, Steve expressed that if APP is going to consider putting art in this location, that a firm design would be needed by Aug. 2021. Initial ideas from the board were a mural, a mosaic of tile or other material, Ceramic art such as fish, similar to the kites in the White Rock Library, and Sea Creatures. Board is to brainstorm ideas for this project with additional information of materials recommended for an enclosed aquatic center environment. At the Dec. 17, 2020 meeting Member Mackey presented two potential artists for the interior, Amanda Jaffe, and, Collette Marie for the exterior of the building. Member Mackey was tasked with further discussing with these artists further details and rough estimate costs for potential art.

At the Jan 2021 meeting Member Mackey provided addition details of the proposed pieces. The Exterior would be a concrete formed lined piece, proposed to be placed above the new windows of the pool. The Interior is proposed to have 5 pieces, each sitting underneath the new windows of the pool, and would need to be sunk at least 2 inches into the wall. Both proposals need extreme coordination with the project manager, Steve Huebner for feasibility in construction timeline and contractor capability an scope. Staff Liasion, Katherine Hudspeth, reached out to Steve Huebner with a summary of Jan. 2021 discussion, asking several questions, Member Mackey was cc'd.

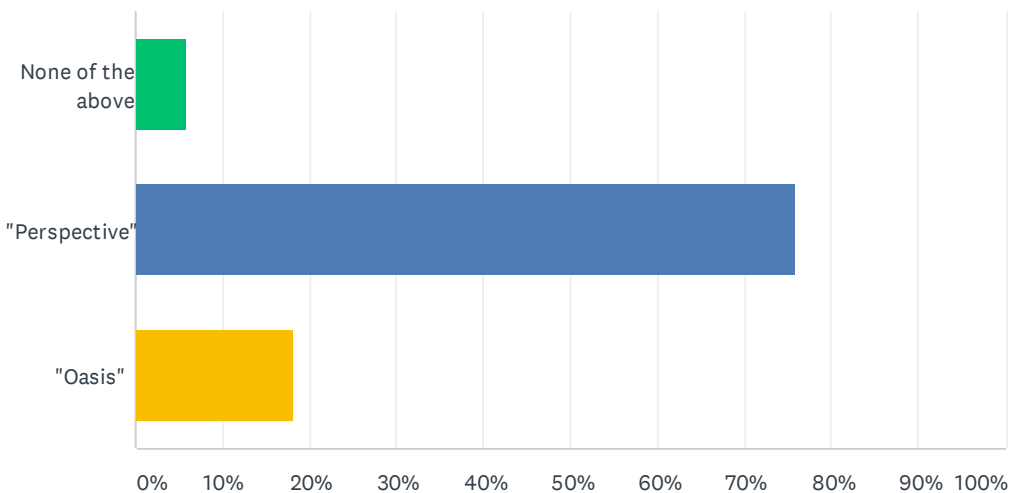

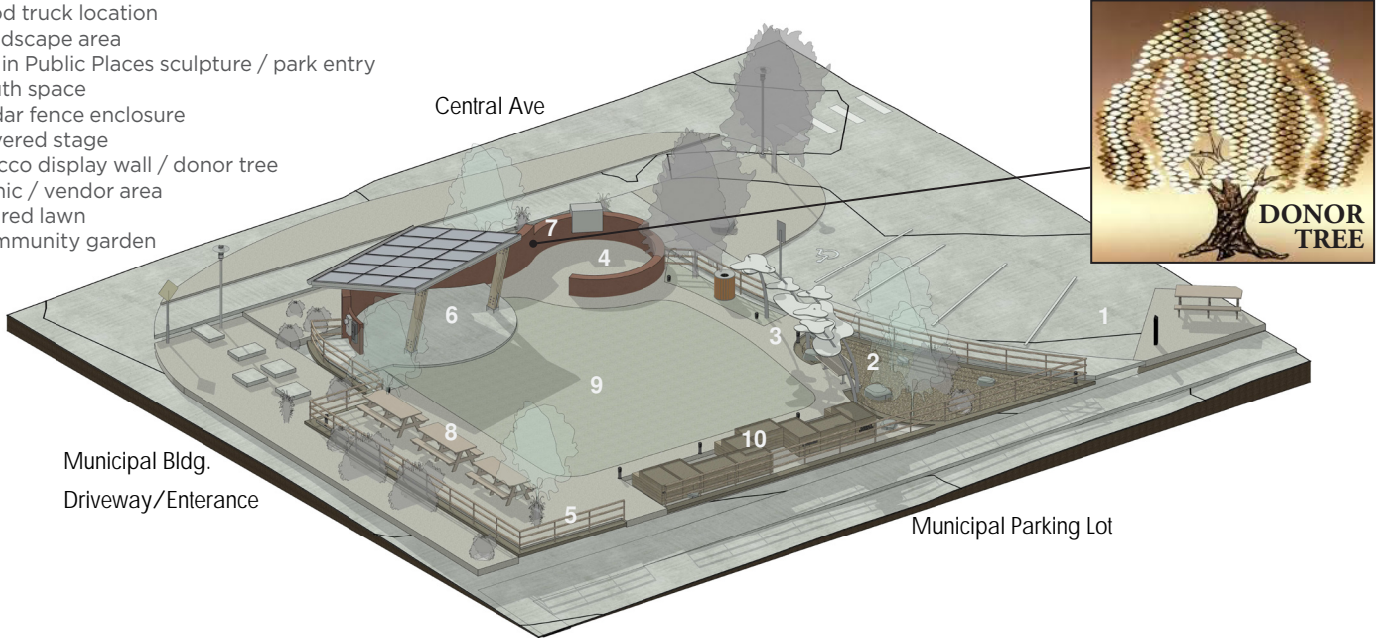

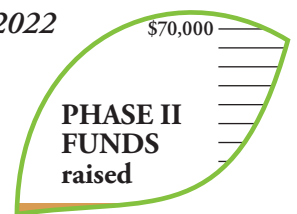

*Cooperatives serve their members most effectively and strengthen the cooperative movement by working together.*

In 2012 six Los Alamos cooperatives met for coffee to explore the idea of a cooperative marketing program: Bathtub Row Brewing, Del Norte Credit Union, Little Forest Playschool, Los Alamos Coop Market, Los Alamos Schools Credit Union, and Zia Credit Union. It only took one meeting for them to all agree this was a great idea and the Keep It Co-Op! movement was born. Since 2012, Keep It Co-Op! members have partnered with each other through food drives, community concerts, shred days, and membership promotions. This year, they are partnering on a much larger scale to benefit the Los Alamos community to help create a community park.

The Los Alamos Schools Credit Union is constructing a new facility at 1010 Central Avenue in Los Alamos, New Mexico, opening in Summer 2021. A green space approximately 80' x 80' in the northeast corner of LASCUs property was presented to the Keep It Co-Op! group as an opportunity to partner together to develop a community Co-Op Park. Phase I of the Co-Op Park, scheduled to be completed in 2021, includes landscaping, picnic tables, benches, raised gardens, shade canopies, a wall foundation, walls, stucco, fencing, and stage electrical. Phase II will be completed in 2022 and includes the stage foundation and stage canopy.

The six original Keep It Co-Op! members have committed to contribute financially to the Co-Op Park. Keep It Co-Op! members are seeking other financial support to make the Co-Op Park a reality. Del Norte LOV Foundation, the philanthropic arm of Del Norte Credit Union, is a donor to the Co-Op Park. Los Alamos Places & Spaces is a potential donor. Keep It Co-Op! is actively soliciting additional contributions from fellow community members to bring this community project to life. Will you contribute today?

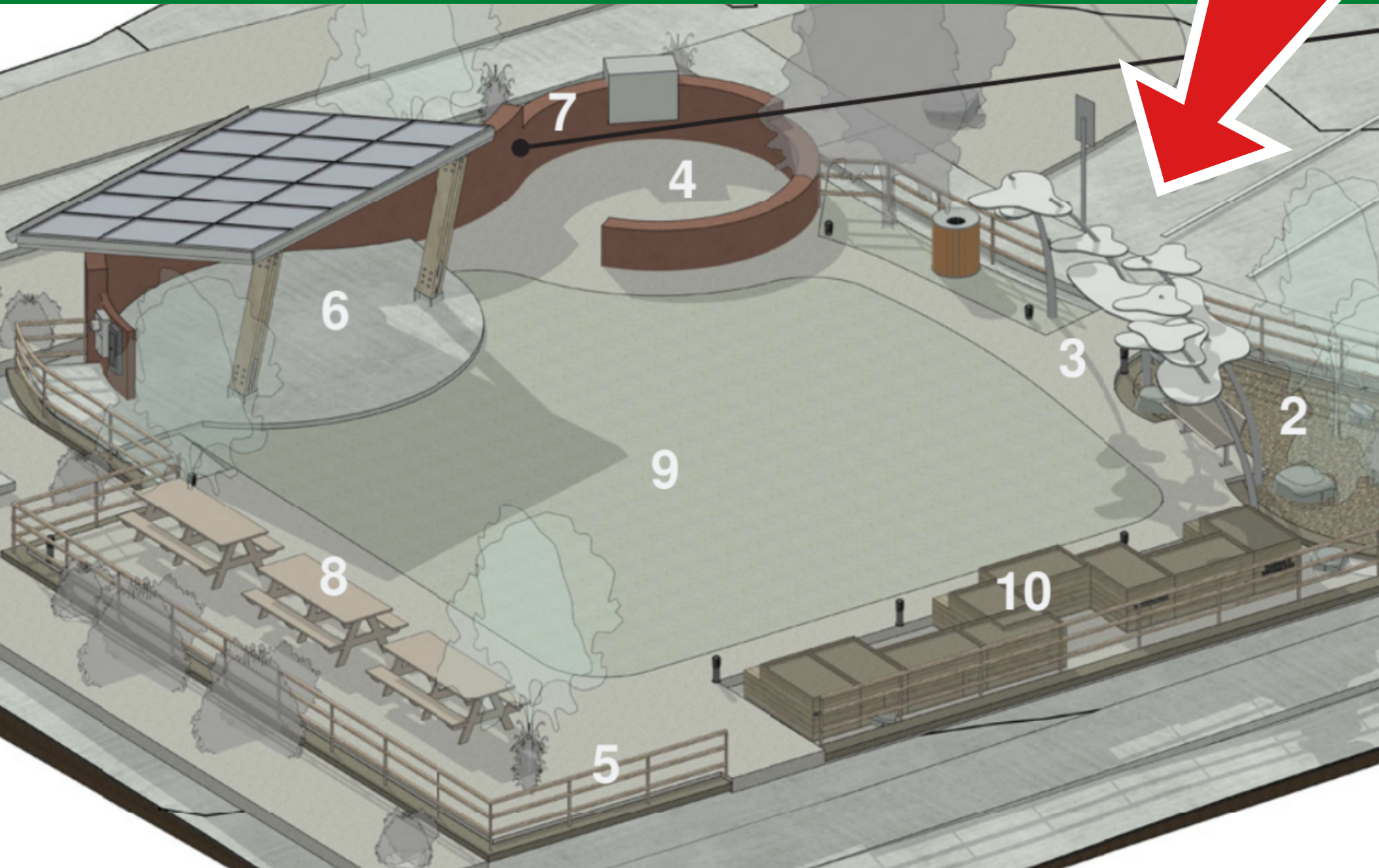

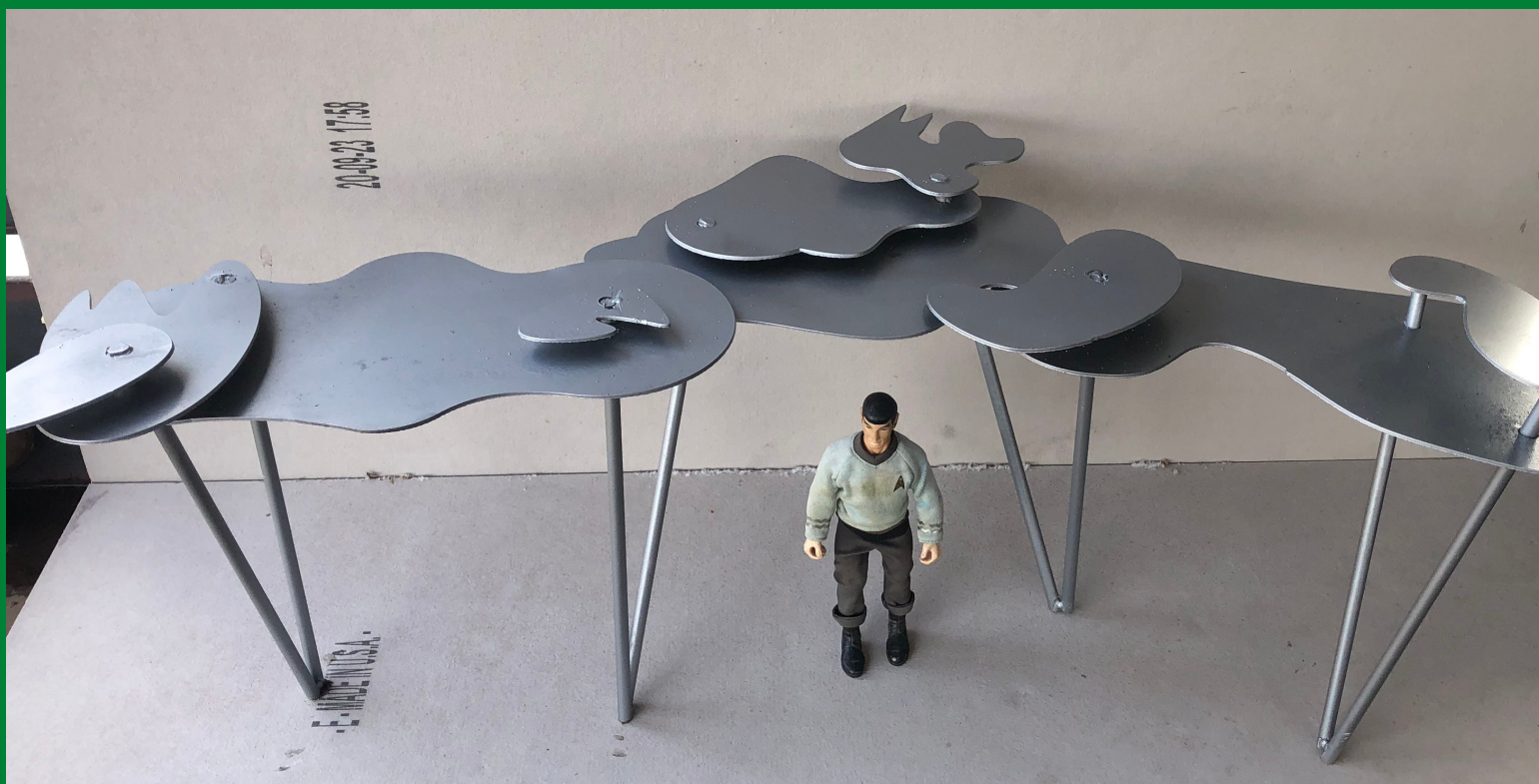
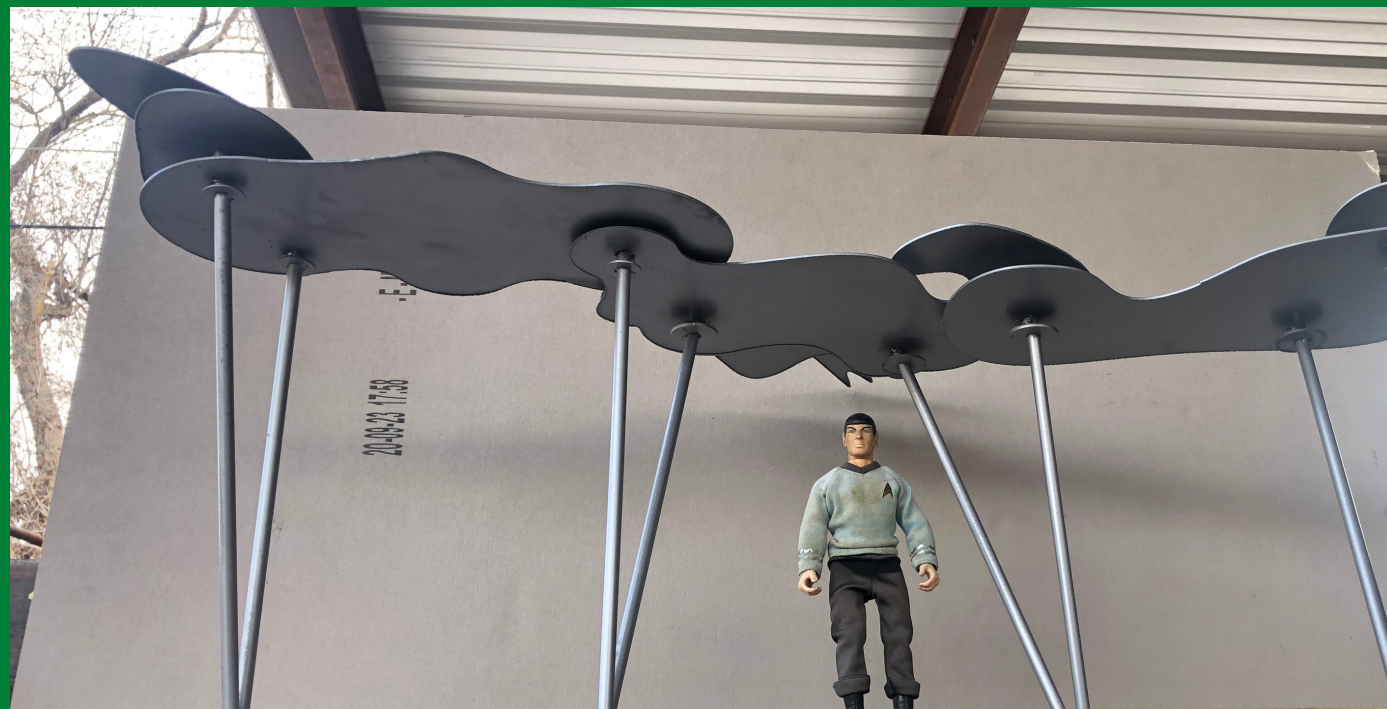

- *Notify the Council liaison of the recommended plan for Council approval and disposition. Disposal of any public work of art requires Council approval, so the Board Chair, the Council liaison, and the staff liaison will formulate a plan and path forward for final Council decision.*
- *Disposal by any means of County-owned public art shall comply with all applicable County and State legal requirements."*
