Dear ESB members,

I thank Dina Pesenson for her sustained commitment to an issue that concerns her, and I thank you all for your service on this Board. Here are my comments after listening to Ms. Pesenson's presentation (I couldnt "see" it on my phone), and reviewing her draft recommendation.

1) stop use of any herbicide containing glyphosate on county land.

I do not consider this proposal to be reasonable, necessary, or helpful to our county.

Ms. Pesenson cited a number of claims that have been made about glyphosate. I was unable to investigate the sources she cited, because her slides were not available in the agenda packet for that meeting nor in the minutes, and as she noted, they were difficult to read onscreen.

Since I can't address the quality of the specific research Ms. Pesenson cited, I will simply offer that if an ESB board member has not previously heard the claims against glyphosate, then it's likely that you also have not heard the strong scientific refutations of the claims. Please feel free to reach out to me with specific questions and I will do my best to find you some objective answers.

Meanwhile, I encourage you to give our County workers the tools they need to do their work, including use of glyphosate where it is merited. See also #3.

2) require pesticide/herbicide application information (including area to be sprayed and product) to be posted in one designated county website location at least 72 hours in advance of each application and for at least 6 months after the application including the Department of Agriculture Pesticide Application Record for the particular application.

This seems to be a reasonable proposal, which would allow individuals who feel especially troubled by the use of pesticides/herbicides to avoid those areas around the time of application.

3) prioritize and support expansion of Integrative Pest Management efforts by relevant departments to continue to actively decrease the amount and frequency of chemical use on county land.

Everything around us, including our own bodies, is made up of chemicals. The use of "phobic" language can be a sign that an issue is not being considerd objectively. Please consider this possibility during your discussions.

Aside from that concern, I support the use of Integrative / Integrated Pest Management approaches. IPM uses a three pronged approach of treatment using the best tool for the job, inspection to ensure that problems are addressed early, and prevention by keeping systems in good health. Whem managed well, IPM can lead to more cost effective operations and improved landscape health.

It is my understanding that this is already the practice of the County's groundskeeping operations.

As a final thought, when I reviewed the County's Environmental Sustainability Plan, this question seems to be on the fringes of what the ESB is asked to advise on. I note in Ms. Pesenson's presentation that she has had good success working with the PRB in the past, and she continues to press forward on that front. In the interest of good governance, I would like to suggest that the two Board chairs and/or their staff liaisons decide which one board should take the responsibility for this recommendation. That a proposal is being offered to mulitple boards suggests that the boards' roles and responsibilities aren't clear to the public.
