**A RESOLUTION OF SUPPORT FOR COUNTY PARTICIPATION IN THE
2022-2023 NEW MEXICO DEPARTMENT OF TRANSPORTATION
LOCAL GOVERNMENT ROAD FUND COOPERATIVE AGREEMENT
FOR IMPROVEMENTS OF VARIOUS COUNTY ROADS IN LOS
ALAMOS, NEW MEXICO, UNDER THE SCHOOL BUS ROUTE
PROGRAM PROJECT NO. L500503**

WHEREAS, pursuant to Section 67-3-28.2, NMSA 1978, assistance for local road construction and repair is available through the New Mexico Department of Transportation from the Local Government Road Fund; and

WHEREAS, the Incorporated County of Los Alamos ("County") applied for funding from the School Bus Route Program for improvements of various County roads in Los Alamos, New Mexico. The total funding amount (including the 25% County participation) is ONE HUNDRED FIFTY THOUSAND FOUR HUNDRED DOLLARS (\$150,400.00); and

WHEREAS, County has agreed with the State of New Mexico to utilize awarded funds from the School Bus Route Program for improvements to the Loma Linda subdivision including the following streets: Loma Linda Drive, La Tierra Road, and La Mirada Circle (the "Project"); and

WHEREAS, to obtain funds from the Local Government Road Fund, a local government must agree to provide matching funds pursuant to Section 67-3-32, NMSA 1978; and

WHEREAS, the Council of the Incorporated County of Los Alamos supports the Project, approved County FY 2023 Capital Improvement Program funds for the Project and shall provide 25% of the funds for the Project, as required under the School Bus Route Program.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Incorporated County of Los Alamos that:

Section 1. The County Manager of the Incorporated County of Los Alamos is authorized to execute the School Bus Route Cooperative Agreement to obtain funds for the Project to improve various County roads in Los Alamos, New Mexico.

Section 2. The Council of the Incorporated County of Los Alamos supports of the Project to improve various County roads in Los Alamos, New Mexico, and shall provide matching funds for the Project in the amount of THIRTY-SEVEN THOUSAND SIX HUNDRED DOLLARS (\$37,600.00).
