Meeting Our Goals

Los Alamos County worked closely with regional, state and national entities on various issues and projects.

News & Updates

Cerro Pelado fire: The Cerro Pelado fire, which began on April 22 just off of Forest Road 10, dominated much of the county staff's time and resources during May. Moving from "ready" to "set" on May 9, Los Alamos County and Los Alamos National Laboratory moved to maximum telework status and Los Alamos Public Schools closed schools. With Atomic City Transit's assistance, the Emergency Manager transported the elderly from Sombrillo and Aspen Ridge and evacuated large animals. Governor Lujan Grisham visited elected and government officials on May 12 to discuss the Cerro Pelado fire status and recommended steps forward. Fire Marshall Wendy Servey also enacted Stage 3 fire restrictions to keep the community safe. Weekly community briefings with representatives from the Great Basin Team, Los Alamos County Fire and Emergency Management Departments, U.S. Forest Service, the National Weather Service, and Los Alamos National Laboratory were held in person at the High School via Zoom and streamed through Facebook. In addition, daily press releases were issued jointly with LANL, DOE, NNSA and Los Alamos County. The County moved back to ready on May 17, with the fire 62 percent contained.

Pandemic: Per, epidemiologist Will Athas, reported COVID-19 cases began to modestly rise in the County in April, as it was in neighboring Santa Fe, Rio Arriba, and Taos counties; the four comprise the Health Services Area (HSA) that CDC uses to calculate Community Level hospitalization metrics. For the week ending May 23, three of the four counties had 7-day total incidence rates well exceeding 200 per 100,000, which automatically confers "medium" risk status regardless of hospitalization rates. As a result, Los Alamos County issued a press release advising the community of available tools for protection against COVID-19: Vaccines/boosters, testing, treatments and masking and social distancing. Los Alamos County Councilors handed out at-home rapid tests at the Farmers Market. Additionally, the County continues to issue a weekly COVID-19 newsletter. Intergovernmental Affairs: The ECA Peer Exchange was held in Carlsbad, NM the first week of May. Along with County Management, three councilors and the Intergovernmental Affairs Manager attended this meeting and toured the WIPP site. Councilor Izraelevitz, a Board member of the ECA, moderated a session on Workforce Development in Areas of Competing Industry.

Joy Esparsen from NM Counties presented to the Council on the organization's programs and support for counties at the May 3, 2022, Regular Council Session. A new version of the LAC Federal Priorities was approved by the Council ahead of a June trip to Washington, DC. The Priorities emphasize land conveyance requests and infrastructure projects, among other issues.

The MOU between LAC, the City of Espanola, and Rio Arriba County for a strategic partnership was approved by all parties' governing bodies. Plans for a signing ceremony and discussions about projects are moving forward. NM Legislative Interim Committees set their schedule for the interim period and began meeting.

News & Updates Continued

Broadband:

Last Mile / CBN (Community Broadband Network):

The Broadband Manager continues weekly project meetings with the broadband consultant CTC. Current focus is working with county staff as they finalize developing a community survey to identify the broadband needs. This hybrid survey (paper and online) will likely be launched in July.

Middle Mile - 2nd Fiber Line:

Partnerships and funding options are continuing to be developed and further considered, with two separate and evolving options for middle mile (2nd fiber line). One option is an opportunity to collaborate with San Ildefonso Pueblo. For the second option, discussions continue with Santa Fe County and PNM, with the latest activity being our working on crafting an MOU for the two counties to work on this 2nd fiber line project together.

Connect NM Council (CNMC) / Office of Broadband & Expansion:

Jerry met one on one with Matt Schmit, the adviser/director of Office of Broadband & Expansion (OBAE). Topics covered included how the county is looking to fund the middle mile 2nd fiber optic line with state and/or federal funds, via the two collaboration options discussed above.

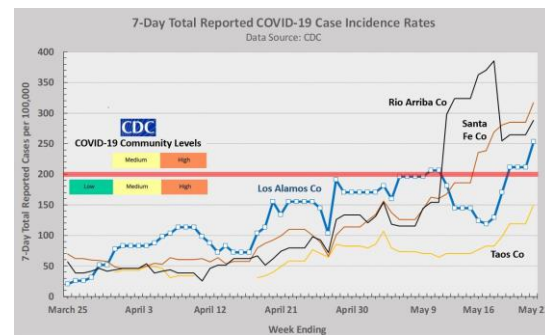
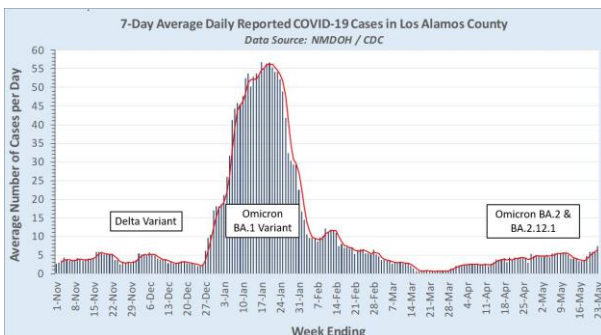

Looking Ahead

The Intergovernmental Affairs Manager and the County Manager traveled with some councilors to Washington DC to meet with legislators in June. Staff will hold a COVID-19 Community Briefing on June 23rd and a vaccination clinic on June 27th.

News & Updates

An RFP process for life insurance is currently being conducted, with a closing date of June 10, 2022.

Between May 1, 2022, and May 31, 2022, there were 36 internal positive COVID cases reported.

Interviews were held for the Human Resources Technician position the week of May 23rd. There are two vacancies we are trying to fill, one in Benefits and one in Recruiting.

With assistance from the HR Training Manager, Stephanie Stancil, Risk is now offering an e-learning Blood Borne Pathogen Refresher training that staff can take in Litmos. There is a prerequisite of completing the in-person training which reviews County Policy, How to Report an Exposure, and the Exposure Control Plan. Thank you, Stephanie, for your assistance!

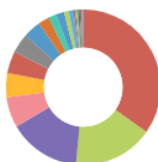

- The County invited over 85 local businesses to participate in ongoing focus groups regarding developing the County's business assistance programs. These programs include a variety of proposed grants and incentives funded by the America Rescue Plan Act (ARPA). Existing and up and coming local businesses interested in participating in a focus group should email Kelly.Stewart@lacnm.us.
- Staff began the preparation of a request for proposals for Home Rehabilitation/Renewal Services Program (HRP) administrative services. The existing program services contract, held by the Los Alamos Housing Partners, expires in July 2022.

News & Updates

- **ICSC Conference.** In late May, EDA Ungerleider attended the annual ICSC conference in Las Vegas, NV. The annual conference is a 3-day gathering of commercial dealmakers and industry experts. Noted meetings held were with Kroger, multiple local and potential lodgers/hotels, movie theaters, daycare, and supporting economic development businesses.
- **North Mesa Housing Project.** EPS consulting firm continues to build the financial model for testing and comparing costs, revenue, and returns for three alternative housing developments on the North Mesa LAPS properties. The draft report summarizing options is expected in July 2022 for presentation before LAPS and LAC by the end of the summer, or early fall.
- **White Rock MRA.** On May 26, 2022, CDD and the project consultant held a project kick-off meeting in White Rock. Over the next three months, the project consultant, Sites Southwest, will be developing the required Metropolitan Redevelopment Plan for the White Rock Town Center. When completed, the County will be afforded new financial tools to support development initiatives outlined in the approved *White Rock Town Center Plan*. More information about the WR MRA planning process will be available on the County's Economic Development website.
- **Mari-Mac.** In a meeting in late May, CDD staff learned that a local developer was able to place Mari Mac property under contract. Next year, the developer hopes to plan and seek approval for a mixed-use development in accordance with the *Los Alamos Downtown Master Plan*. More information will be shared as it becomes available.

News & Updates (continued)

- **Reel Deal.** It has come to the County's attention that the owner of LA Network has the Reel Deal Theater property under contract. More information will be posted as it becomes available.
- **REDI Plan Update.** EDD is drafting a revised Regional Economic Development Plan with the Regional Development Corporation (RDC) and the North Central New Mexico Economic Development District. The revised plan is being developed based on input from several local and regional focus group sessions, updated industry data, and best practices. The draft will be presented to Council later this summer for consideration and endorsement.

Connecting with the Public

Annual CVU Report. On May 26, 2022, EDD distributed its annual *Community Vitality Update* report via the Los Alamos Daily Post. Copies of this document are available at each of the Los Alamos and White Rock visitor centers and public libraries and posted online on the County's Economic Development webpage. This document was completed in collaboration with the County's EDD internal and external partners.

STATS Update

Planning staff reviewed and acted on 45 Building permits and 8 Business License applications.

Code Compliance Officers opened 32 new code cases and closed 15 cases.

Meeting Our Goals

The Community Development Planning Division has been focused on the Chapter 16 and 18 updates. Division Staff continue to maintain a high level of customer service with ongoing planning and code compliance cases.

News & Updates

The Chapter 16 Development Code Update process has continued to progress with Planning staff and County consultant, Dekker/Perich/Sabatini. Steering committee meetings are currently being held on Module 3 of the update effort.

No Planning & Zoning Commission meetings were held in May.

Planning staff presented to County Council on May 24th Ordinance 02-320, an ordinance amending the text of Chapter 16 to adopt local regulations for mobile food vending. The proposed text amendment was staff-prepared and received unanimous approval by the County Council.

The Chapter 18 Nuisance Code Update has also continued to progress with Code Compliance staff and County consultant Dekker/Perich/Sabatini. A Community Development Advisory Board meeting was held on May 16th.

Connecting with the Public

Module 3 of the Chapter 16 Update effort is anticipated to be released for public review and comment in June.

Meeting Our Goals

Meeting Our Goals

Improved the open spaces, recreational, and cultural amenities Los Alamos Golf Course maintenance team conducted their spring aerification application on May 9 and 10. The process includes the aerifying machine plugging the greens, the vacuum to pick up plugs, the jet blower to blow off remaining debris not picked up by the vacuum, the sander to apply top dress, and then finished off with a 3-to-5-minute water cycle. The process is precise and moves in order around the golf course.

Park Staff improved open spaces, recreational, and cultural amenities through landscape maintenance, construction, and beautification across Los Alamos County.

Park Staff prepped Ashley Pond for the Summer Concert Series and continues to maintain the park. From tree and ground maintenance, electrical, pond cleaning, restroom repairs, and the placement of the canopy on the stage.

Invested in infrastructure The Los Alamos County Park Staff installed multi-use fountains (drinking, bottle filling, and dog amenities) at the splash pad in White Rock, Ashley Pond, and North Mesa Sports Complex in conjunction with Environmental Services through a grant program.

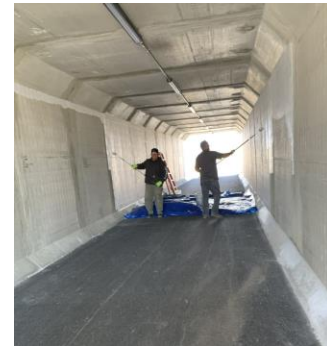

Operational Excellence: The County held voting machine certifications on May 3rd and 19th to ensure accuracy of the vote counts. Early Voting for the 2022 Primary launched smoothly at both the Municipal Building (May 10th) and White Rock Town Hall (May 21st) sites.

Currently, the Clerk's Office maintains a records database with nearly 130,000 electronic public record documents, with retrieval assistance and access provided to the public daily. The Clerk's Office is currently open to the public, and to help in the management of traffic flow, the office has implemented an online process to schedule appointments, a link is available on their website www.losalamosnm.us/clerk. Customers may continue to drop off items in the designated Drop-Box located outside the Clerk's Office.

Clerk Maestas would like to remind customers of services that are available online. To search the real estate recordings and government document filings, customers may use the Online Records Portal. For searching probate and marriage records, or to apply for a marriage license, customers may use the Probate & Marriage Online Records Portal. Both links are available on the Clerk's webpage at www.losalamosnm.us/clerk.

There are a few election-related items that can be handled online or through the United States Postal Service. Citizens are reminded to utilize NMVote.org for voter registration and for other election-related services, i.e. voter registration, and absentee requests.

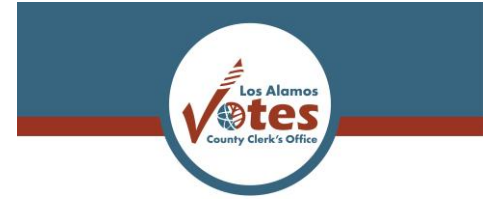

Meeting Our Goals

Consistent with the Council strategic priority to invest in infrastructure, the Engineering Division has been actively working towards completion of multiple project designs by in-house engineering staff and has seen the kick-off of additional construction projects. Canyon Road, and Cumbres del Norte were both advertised for construction with bids received and evaluations completed. Canyon Road received council approval for award while Cumbres del Norte construction began in the last week of May. The design for the 33rd/34th Street/Arkansas project was completed and advertised with no bids received. This project will be re-advertised later in the year.

News & Updates

On May 3, Council approved a contract with iConsult LLC (dba iCon Golf Studio and Grass Roots Golf Design) for golf course design services. Services for the project is separated into two phases. Phase 1 includes assembly of design drawings and construction documents for improving Holes 4 through 18, while Phase 2 includes development of design concepts for improvements to Holes 1 through 3, the driving range, and other improvements such as practice area and cart path upgrades.

Other projects in design include DP Road Phase II Infrastructure Project with the design completed in May and tentatively advertised for bids in July 2022. Construction of this project has been delayed due to supply chain issues and will begin in early 2023. The Urban Trail Phases 1 and 2 is a joint design effort between our division and one of our engineering on-calls with design being finalized and construction anticipated in Spring 2023. The Trinity Safety and ADA Improvements design project is underway with the development and evaluation of design alternatives forthcoming.

Connecting with the Public

Project Managers have been busy managing current construction projects such as the Sherwood Boulevard and the new Cumbres del Norte projects. A press release and door hangers were issued for the Cumbres del Norte project updating the public on the construction start date and reminding them about safety around the work zone. A public meeting was held May 26, 2022, to kick-off the Golf Course Improvements Project. County staff met with members of the community for a listening session to kick-off the project, meet the design team and discuss any concerns or share input prior to the commencement of design work.

Looking Ahead

Staff submitted Transportation Project Fund grant applications in May for the FY23 Loma Linda and Rose Street projects. The County has been very successful in previous years in securing this grant funding which is then used to help fund county CIP projects. Staff requested and received \$525,000 of additional funding from the NMDOT through the Federal Bipartisan Infrastructure Law for the Urban Trail project that will be used to cover cost escalations. Staff was also notified in May that the application to NMDOT for FFY2023/2025 Federal Funding for the NM4 Crossing and Multi-Use Trail Improvement Project in White Rock was successful with a total award amount of \$2,750,000 inclusive of county match.

The team also discussed the upcoming June events. The Green Restaurant Certification Team will have their first meeting in June. The team's goal is to educate restaurants on what it means to be a green restaurant and green certified.

The Environmental Sustainability Board meeting, May 19, 2022, was conducted via Zoom. The ESB received a presentation from about Supporting Pollinator Protection at Los Alamos National Laboratory with informational resources provided by Jenna Stanek. The presentation reviewed what pollinators are and why they are important. Pollinator populations have been declining and there are several nationwide initiatives to combat the decline. The DOE also has developed a pollinator protection plan. The ESB received a presentation from Member Emerson about Seed Libraries. A seed library is both a collection of seeds and a community of gardeners and farmers. There are seed exchanges and swaps, a seed borrower's pledge, a safe seed pledge, and seed banks to secure the conservation and destruction of seeds. The Board Staff Liaison Angelica Gurule provided the Board a staff update which included upcoming events, request for volunteers, and the April 2022 Residential Sustainability Report. The ESB is currently recruiting to fill one vacancy.

The Environmental Sustainability Board presented a yearly update to County Council at their May 17, 2022 work session focusing on what the board has completed and what they will be working on in the future. Also at this meeting Environmental Services Manager, Angelica Gurule, provided an overview of the Food Waste Composting Feasibility Study and ESB recommendation to implement a food waste composting system at Bayo Canyon using a window system and provide drop off sites for residents and curbside collection for businesses.

News & Updates Continued

Environmental Services in partnership with PEEC and LAC Parks and Recreation Division received a partial award to purchase and install three water bottle refill stations. The first refill stations have been installed at Ashley Pond and the Splash Pad. The third will be installed at Overlook Sports Complex.

Due to the Cerro Pelado Fire, Environmental services observed an increase from the same time last year in the amount for brush, tree trimmings, and yard waste received. Commercial brush increased 726% from 63.6 tons to 523.47 tons, residential customers bringing in brush increased 138% from 358 to 853 customers. Environmental Services also provided an additional pick up for yard trimming roll carts the week of May 16 – 20 to assist residents in the removal of fuels for fire mitigation.

Connecting with the Public

We are excited to bring back in-person events this year. Environmental Services, Zero Waste Los Alamos, And the Environmental Sustainability Board will host Booths at Farmers Markets, the Summer Concert series and other community events as well as a return of Clean Up Los Alamos Day.

Environmental Services conducted our first spring cleaning session at the White Rock Demo Garden on April 27, 2022. It is located at the White Rock Visitor's Center.

Recycle Coach app is a great asset for residents to check collection schedules and use the 'What Goes Where' search tool for recycle questions. The number one customer interaction is collection day reminders and real time notifications.

Yard Trimming collection officially began May 14, 2022. The yard trimming roll cart is for organic yard trimmings only, which includes short branches, flowers, grass clippings, leaves, pine needles and pinecones. Residents are allowed one cart per household. Register for a Yard Trimming Cart online at www.losalamosnm.us/gogreen

Looking Ahead

Nominations and selection for the 2022 Zero Waste Champion of the Year Award have ended. The winner's will be announced at Chamber Business Awards on June 3, 2022. Following the award's ceremony, we will host the Zero Waste booth at the Los Alamos Concert Series for the Kat Wright concert.

Reminder: Environmental Services, ESB and Zero Waste Los Alamos will host our first Farmer's Market booth on June 23, 2022. We have a lot of information about food waste reduction, recycling and zero waste.

Environmental Services and the Zero Waste Los Alamos Team have a Zero Waste Party Kit available that you may reserve for your next event! The kit includes approximately fifty (50) table setting, including: large plate, cup, fork, spoon, butter knife and napkin.

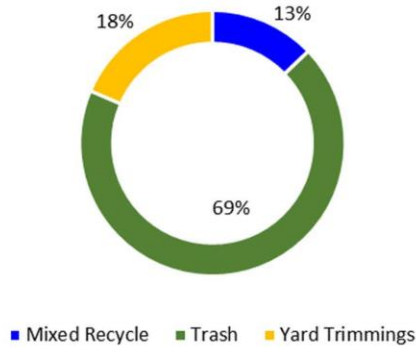

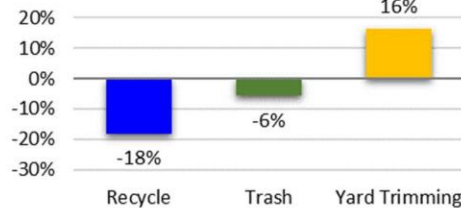

Monthly Collection Report

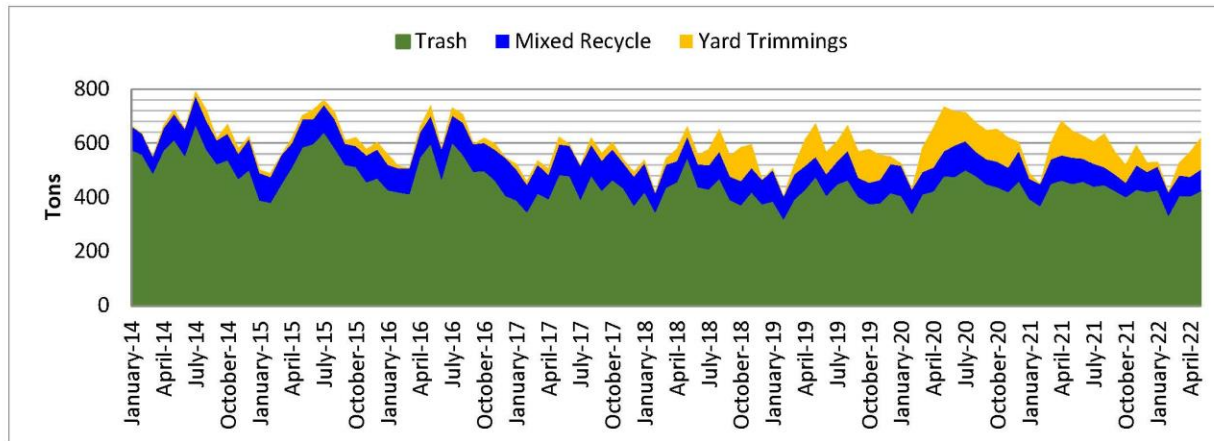

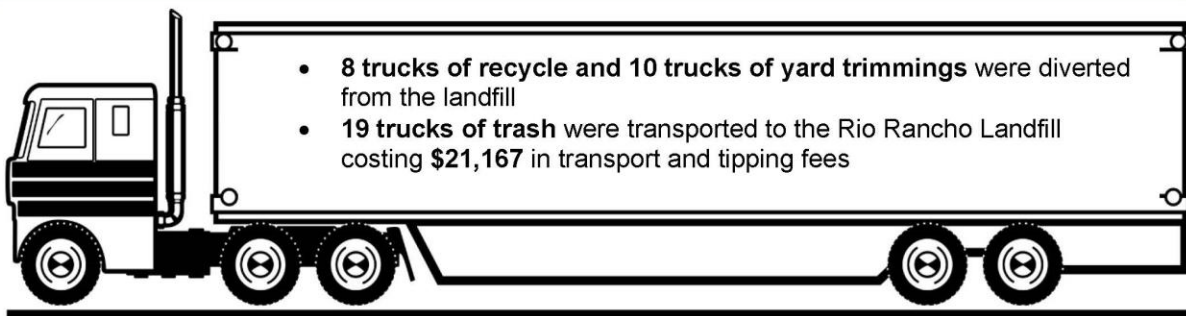

Meeting Our Goals

Traffic: Traffic and Streets division met county council goals in the month of May by maintaining roadways, sidewalks, county owned parking lots and property. Also, by working with the public to resolve any concerns regarding our right-of-way.

Fleet: Fleet is focused on keeping vehicles and equipment in top shape so Los Alamos County customers can provide quality services to the residents of Los Alamos and White Rock. Fleet also provides a Motor Pool service that is located at the Municipal building available to County staff.

News & Updates

Traffic: Streets crews bladed the evacuation route in the Rendija Canyon in case the County moved to 'Go Status'.

Streets crews placed millings at Airport at end of runway. They also assisted Parks division in removing dirt from North Mesa and repairing the rock wall in Quemazon.

Streets crews hauled 120 tons of base course material to replenish their bins at PCS for the construction season.

The Signs and Markings crew have been striping no parking areas and streets county wide. Crews will be re-painting crosswalks county wide including at all the schools in preparation for the next school year.

Traffic Electricians have replaced lighted street signs on Diamond Drive at the intersection of Sandia and Orange Streets.

Traffic Electricians were called out to Trinity & Knecht to repair a damaged 5 section head and a 3-section head on pole East bound, due to truck hitting traffic signal. They were also called out to replace a 5-section head on a traffic signal at Trinity & 7th, due to wind damage.

Traffic electricians repaired 5 runway lights at the Airport and raised secondary electric lines for parking lot lights.

Crews attended Flagger Training held by associated contractors of New Mexico "ACNM". The training prepares employees to properly direct traffic through work zones.

Administrative staff have been working with contractors and county project managers in reviewing and issuing permits for construction projects countywide. During the month of May, 13 permits were issued.

Staff coordinated with the LAPD for transporting mobile homes off the hill and modular homes to various sites within the county.

News & Updates Continue

The construction season is upon us, we urge the public to be cautious when approaching any devices to avoid any hazardous situations.

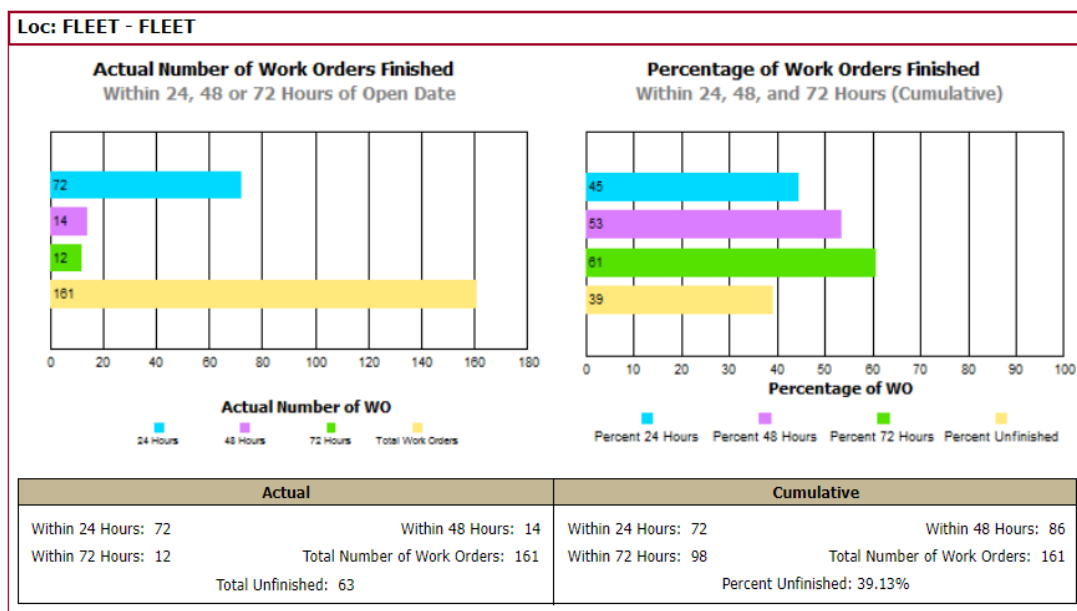

Meeting Our Goals

Airport: The proposed Fuel Farm for the Los Alamos County Airport has been selected by the NMDOT-Aviation Division as a recipient of a \$1,900,000 grant using ARPA funding for construction. This is a no-match grant for the County. The fuel farm will contribute to the airport's financial self-sufficiency. It will also provide fueling capabilities for fire and other emergency related aircraft as well as for any future scheduled air service.

Transit:

Supporting social services improvement

Atomic City Transit provides support to behavioral, mental, and physical health services along with social services by providing transportation to Los Alamos Medical Center, various medical providers as well as the Los Alamos Senior Center, Los Alamos Aquatic Complex and All Individual First day center. Transportation is the gateway to independence for residents of Los Alamos County.

Investing in infrastructure

Atomic City Transit attended the "Kick-Off" meeting with LSC Transportation Consults, Inc to discuss and finalize a timeline of completion for the Los Alamos County Comprehensive Transit Study and Updated Service Plan.

The study's scope of work includes exploring option to enhance the current transit design, coordinated efforts of working with LANL, NM DOT Park N Ride, Los Alamos Public Schools, North Central Regional Transit District and Bandelier National Monument on improve coordination between services. The study will provide on-board rider surveys as well as public meetings to gather community input through the monthly Transportation Board meetings. We have included the request to provide options of alternative fuels, specifically electric powered vehicles and the costs associated with this alternative.

News & Updates

Airport: The airport recently had its FAA Airport Master Record inspection from both the FAA and NMDOT representatives. They found the airport to be in very good condition. They asked that the crews that take care of and repair the airport and its facilities to be acknowledged for their efforts. All of the items identified are currently included the airport's Five-Year CIP.

The airport hosted the Gov. Lujan-Grisham during her visit to the community for the recent wildfire event.

Two EMS fixed wing aircraft visited Los Alamos on the same day.

News & Updates (Continued)

Transit: The purchase of the two electric buses and charging stations continue to undergo contract negotiations. We are hopeful this process should be completed in the next couple of months. Transit Division has completed the division portion of the FY 2023 budget process and submitted to finance.

Transit Division completed the negotiations with the Department of Interior to continue service to Bandelier National Park for an additional five- years. Bandelier Shuttle service start date has been changed to June 1, 2022 and is dependent on the containment of the Cerro Pelado fire as well as air quality. We are excited to begin this service we have been unable to provide for two seasons.

Connecting with the Public

Airport: The Airport hosted the Weather Channel during its report on the New Mexico fires. They set up in the parking lot and coordinated with the land management agencies for a special report on the fires.

Working with the Experimental Aircraft Association, the AvGas Co-op, and the Civil Air Patrol to hold an airport open house during the summer.

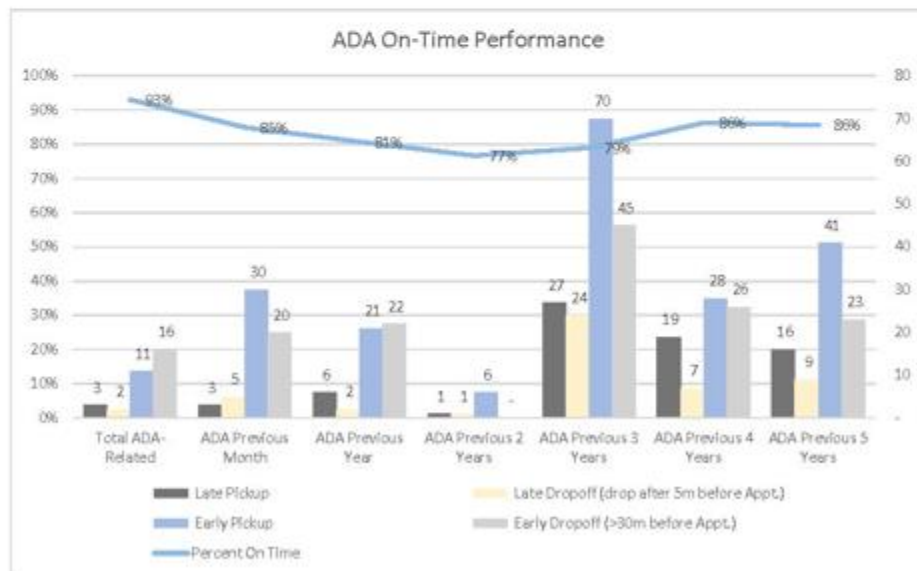
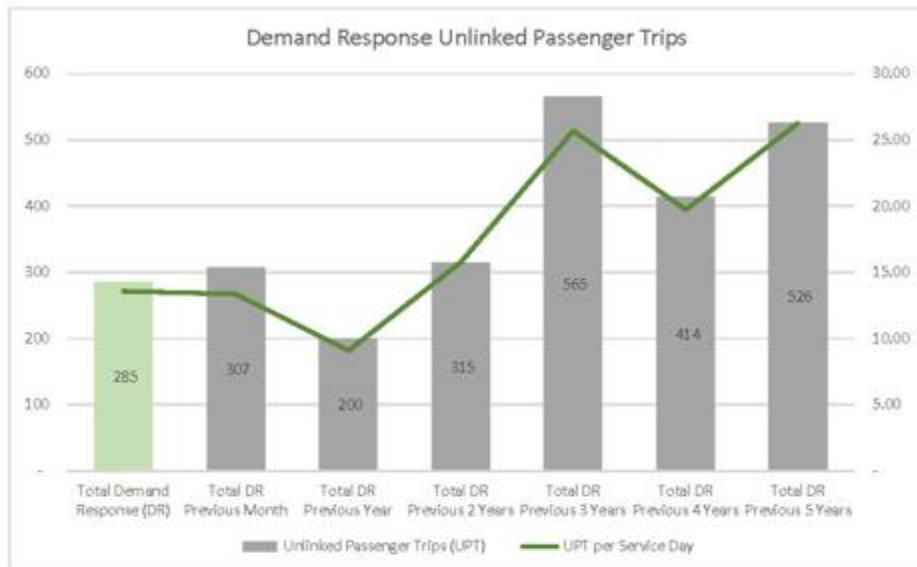
