#### FINAL ORDER AFFIRMING THE DECISION OF THE PLANNING AND ZONING COMMISSION APPROVING SPECIAL USE PERMITS SUP-2020-0014 AND SUP-2020-0015, FINDINGS OF FACT AND CONCLUSIONS OF LAW

**THIS APPEAL** came before the Los Alamos County Council ("Council") pursuant to Sec. 16-493 of the County's Code of Ordinances for a public hearing, on Tuesday, November 10, 2020.

**NOW THEREFORE**, the decisions by the County's Planning and Zoning Commission ("Commission") in Case No. SUP-2020-0014 and Case No. SUP-2020-0015 granting these two Special Use Permits are hereby **AFFIRMED**.

In support of this Final Order, the Council issues the following:

#### I. STANDARD OF REVIEW

In reviewing these decisions of the Commission, the County Council is bound by the following standard of review:

The appellate body shall hold a hearing on the entire record sent to it and reverse, affirm, or modify the decision appealed. The appellate body shall affirm the decision appealed unless it finds that the decision was not in accordance with adopted county plans, policies, and ordinances, the facts on which the decision was based are not supported by the record, or the decision was arbitrary, capricious, or a manifest abuse of discretion.

#### II.. FINDINGS OF FACT

1. The Special Use Permit application #2020-14 is for the operation of an in-home daycare facility for up to 12 children at 113 B La Senda Road, White Rock, NM 87547 ("Property").

2. The Special Use Permit application #2020-0015 is for a home business at the Property to employ more than one non-family member for an in-home day care facility.

Los Alamos County Council Regular Session November 10, 2020 Item 11.E.2 3. The Property is a 3-acre parcel zoned Residential-Agriculture (R-A which allows of the operation of an in-home daycare facility if the criteria for a Special Use Permit as provided for Section 16-156 are met).

4. The employment of more than one non-family member for an in-home day care facility is allowed if the criteria for a Special Use Permit as provided for in Section 16-156 are met.

5. As provided in the 2<sup>nd</sup> Amended Record ("Record") provided to the County Council, and in accordance with Section 16-156 of the Code of Ordinances, the Commission heard evidence on whether each criterion for each Special Use Permit were met. This included, but not limited to, the following:

A. The sworn, questioned, and cross-examined testimony of the applicant, Denise Mathews, which provided facts and reasons why the proposed use does meet each criterion for each Special Use Permit. (See generally Lines 595 through 1099 of the Commission's Hearing transcript ("Transcript") contained in the Record.)

B. The sworn, questioned and cross-examined testimony of Desirae J. Lujan, Associate Planner, Los Alamos Community Development Department, which provided facts and reasons why the proposed use does meet each criterion for each special use permit. (See Lines 1100 through 1383 of the Transcript contained in the Record.)

C. The Los Alamos County Community Development Department Staff Report and recommendations for the Commission, were accepted by the Commission and entered into the record as additional evidence which provided facts and reasons why the proposed use does meet each criterion for each Special Use Permit. (See Lines 412 through 418 of the Transcript showing the Staff Report and other exhibits were admitted into Record.)

D. The sworn, questioned and cross-examined testimony of affected parties disputing that each criterion for each Special Use Permit are met. (See Lines 1358 though 1732 of the Transcript contained in the Record.)

E. Correspondence from affected parties disputing that each criterion for each Special Use Permit are met as shown in the Record.

6. Notice of the June 10, 2020 hearing setting forth the nature of the request, the specific parcel of property affected, and the date, time and place of this public hearing, was announced and published in accordance with Section 16-192 which included the following: publication in the Los Alamos Daily Post, a newspaper of general circulation; notice of the June 10, 2020 hearing before the Planning and Zoning Commission were mailed to known property owners within a 100 yard radius of the Property on May 26, 2020; and notice posted in a conspicuous place at the County Municipal Building at least 15 days prior to the public hearing.

7. Appellants timely filed an appeal of the Commission's decisions in accordance with Section 16-492.

Los Alamos County Council Regular Session November 10, 2020 Item 11.E.2 8. This appeal was properly before Council and the appeal procedures were followed in accordance with Section 16-493.

#### III. CONCLUSIONS OF LAW

Based on the foregoing findings of fact, the following conclusions of law are made:

1. Although there was a conflict in the evidence presented to the Planning & Zoning Commission on whether the criteria for each Special Use Permit were met, there is sufficient evidence in the record for a rational finder of fact to conclude that each of the criterion for each Special Use Permit were met. Therefore, the decision reached by the Commission is supported by the record; and

2. The decision by the Commission is substantially in accord with adopted county plans, policies, and ordinances; and

3. Considering the record as a whole, the procedures followed, and the conclusions drawn by the Commission from the totality of the evidence presented, the decision by the Commission was not arbitrary, capricious, or a manifest abuse of discretion, and therefore,

4. Based on the above findings and the standard of review, the County Council must affirm the decision by the Commission to grant the Special Use Permits at issue.
