C. Liaison's Reports

1). Board of Public Utilities - Erik Loechell

Chair Loechell reported that the Board of Public Utilities (BPU) discussed that the NU Scale Modular Nuclear Reactor has lost a few of the original subscribers but is now searching for new ones. Due to Los Alamos County being one of the first to subscribe, LAC has the first right of refusal to increase the subscription. BPU asked if the Environmental Sustainability Board (ESB) would give feedback as to whether it would be a good idea to look into segregation of materials in the recycle stream. The BPU set their environmental goals after public polling to ask LAC residents if they supported these goals. During the polling they found that more residents supported the goals than did not. BPU approved an amendment to the Power Renewable Energy Credit Sales Agreement between Juniper Global Commodities and Los Alamos.

Member Rogers reported that Parks and Recreation Board talked about the updates of many projects going on around Los Alamos County including: Tree replacement for the willow at Ashley Pond, fixtures for arena lighting at the rodeo grounds, the extension of the bike trail from the ski hill to the LA canyon, and resurfacing of tennis courts. They are currently looking for a new contractor for the BMX course to have it done by this summer.
