






### 2021 Fixed Route Service Area

### **Current Service Provided**

- Hourly service in seven neighborhood routes (Main Hill to/from White Rock, Truck Route to/from White Rock, Canyon/Central, North Community, Barranca Mesa and North Mesa) between 6:00 a.m. and 7:00 p.m.
- Twice an hour service on one neighborhood route (North Mesa) and White Rock during peak periods
- Service every 30 minutes on three routes (Downtown Circulator, North Community and Canyon/Central) between 6:00 a.m. and 7:00 p.m.
- Service every 15 minutes on the Downtown Circulator during peak periods
- ADA Complementary Paratransit Service for individuals with disabilities during the same days and hours of the fixed route service
- Dial-a-Ride service for the general public between 6:30 p.m. and 9:00 p.m. Monday through Friday.
- Seasonal service between White Rock and Bandelier National Monument 7 days per week from approximately 9:00 a.m. to 5:10 p.m. Frequency is every 30 minutes on weekdays and 20 minutes on weekends and holiday weeks.
- Afternoon Express service operates only on school days and is open to the general public. In addition to scheduled drop off locations, Afternoon Express buses drop riders off at other marked bus stops along each of the routes, with the exception of bus stops located on Trinity Drive.

### **Contractor Tasks**

- 1. Review the existing Atomic City Transit Service Plan and discuss ACT's current operations with respect to the existing plan.
- 2. Explore transit demand through existing data and solicitation of community input including public meetings in Los Alamos and White Rock.
- Conduct on-board passenger surveys to identify how the system can best serve riders.
- 4. Research Los Alamos National Lab intern needs for transportation and recommendations to meet those needs
- 5. Interview and obtain system input from Transit Manager, Supervisors, Lead Operators, Dispatchers and Transit Operators, Fleet Manager, Fleet Supervisors and Fleet Mechanics. Review Los Alamos County Downtown Master plan and recommendations with transportation.
- 6. Conduct analysis and evaluation of the existing service/routes in terms of improving efficiencies and meeting community demand. Review routes and connections, as well as schedules. In addition, develop recommendations for proposed microtransit applications within the county service area.



### Contractor Tasks Cont.

- 7. Research and recommend coordination with the existing regional connectors to Espanola, Santa Fe, Albuquerque, and Taos, including connections via NCRTD, Park and Ride, and Rail Runner and Los Alamos National Lab L.A. Taxi Service
- 8. Recommend and prioritize options for changes/improvements/additions to the existing service/routes, including options for pilot projects, that will improve efficiencies and safety and meet community demand.
- 9. Research and recommend the possible weekend service design connecting the Los Alamos Townsite and White Rock to support local and visitor travel and cost analysis for implementation.
- 10. Evaluate staffing requirements for various service and funding scenarios proposed in the Draft Five Year Transit Plan.
- 11. Evaluate the existing driver schedules in order to identify potential efficiencies and/or deficiencies with the regards to the commendations made in the Draft Five Year Transit Service Plan.
- 12. Evaluate the existing fleet (including number and size of vehicles) and develop Draft Purchase and Replacement Schedules corresponding to the difference service and funding scenarios proposed in the Draft Five Year Transit Service Plan.



### Contractor Tasks Cont.

- 13. Evaluate the existing fleet with the goal of adding additional electric powered vehicles for use within the existing or proposed route structure. Develop a draft Service and Cost Analysis Report specific to using Electric Source Fuel Vehicles and provide existing or proposed routes that could use such vehicles.
- 14. Prepare a Draft Transit Study Results Report and Draft Five Year Transit Service Plan with an Executive Summary, include scalable scenario options based on various service levels and available funding.
- 15. Develop and include a corresponding Draft Financial Plan for Operating and Capital Costs, with funding source breakout for each of the possible service and funding scenario in the Draft Five Year Transit Service Plan.
- 16. Present the Draft Transit Study Results Report and corresponding Draft Financial Plan to the T-Board for comment and suggested revisions before finalizing and presenting the Transit Study for consideration and approval by Council.
