Both presentations provide a high level overview of the Electric Production operation and power generation assets. The Department of Public Utilities operates and manages the electric production assets to serve its customers with affordable, reliable and safe electric service. This is accomplished through multiple contracts, a mix of power generation resources along with the transmission and the distribution system network to serve our customers.

The assets include the San Juan Generating Station near Farmington New Mexico operated by the Public Service Company of New Mexico and the Laramie River Station located in Wheatland Wyoming operated by Basin Electric Power Cooperative. The County owned and operated renewable assets include the Solar PV array and hydroelectric facilities at the Abiquiu and El Vado reservoirs located in Northern New Mexico.

Mr. Garcia introduced Mr. Adam Cooper, Hydroelectric Plant Supervisor. Mr. Cooper provided an annual update of the hydroelectric facilities at the Abiquiu and El Vado reservoirs located in Northern New Mexico. Incorporated County of Los Alamos Code Ordinance No. 02-329; An Ordinance Amending Chapter 40, Article III, Sections 40-151, and 40-152 of the Code of the Incorporated County of Los Alamos Pertaining to Gas Service Rates.

Chair Wright stated that this public hearing was originally scheduled for July 20, 2022. However, due to County-wide internet issues on that date, the hearing was rescheduled for August 3rd. Ms. Garcia provided a brief update of Code Ordinance 02-329, which was introduced to the Board of Public Utilities at their regular meeting of June 15, 2022. The proposed increases are expected to generate, in Gas Distribution, \$229,280; \$391,535; \$568,830; and \$662,083 for FYs 23, 24, 25, and 26 respectively.
