After the interviews, the applicants' names are presented to the full Council during a regularly scheduled Council meeting, where a vote is taken regarding the appointment of each applicant. Each applicant will be notified if they are appointed or not.

1	<p>Please tell us a little about yourself, especially your experience and background related to this board/commission.</p> <p>Owner of Petree Garden Center. She is in the business of helping people choose, install sustainable landscaping. The climate in Los Alamos is changing, we are feeling it in our arid environment. She is focused on helping residents choose tree species that will survive here in LA in the future. She is an arborist, background integrated pest management, works with PEEC fairly extensively over the year. She has volunteered over the year. As a small business everything they do is related to sustainability.</p>
2	<p>Why would you like to serve on this board/commission?</p> <p>Personally, she feels like she has a civic duty to participate. She wants to leave a good legacy. Beyond that she is interested in composting in our County, she has experience and can contribute. She is concerned about the deer situation in the County.</p>
3	<p>What do you believe are the major issues facing this board/commission?</p> <p>Deer, composting, bags. Deer are an issue for the long run, we have disrupted the natural balance in our community of predator/prey situation. This causes more ticks, etc. Solid waste is an issue - recycling can be improved.</p>
