# What Council Adopted

2

- 2026 Strategic Leadership Plan - Environmental Stewardship, Climate Action and Resiliency
  - Implement the roadmap for reducing greenhouse gas emissions, achieving a carbon neutral energy supply, and increasing climate resilience
- Achieve carbon neutrality by 2050
- Become a carbon-neutral electric provider by 2040
- Phase out natural gas for:
  - County operations by 2050
  - Community by 2070

- Constructed six level 2 EV chargers at Municipal Building

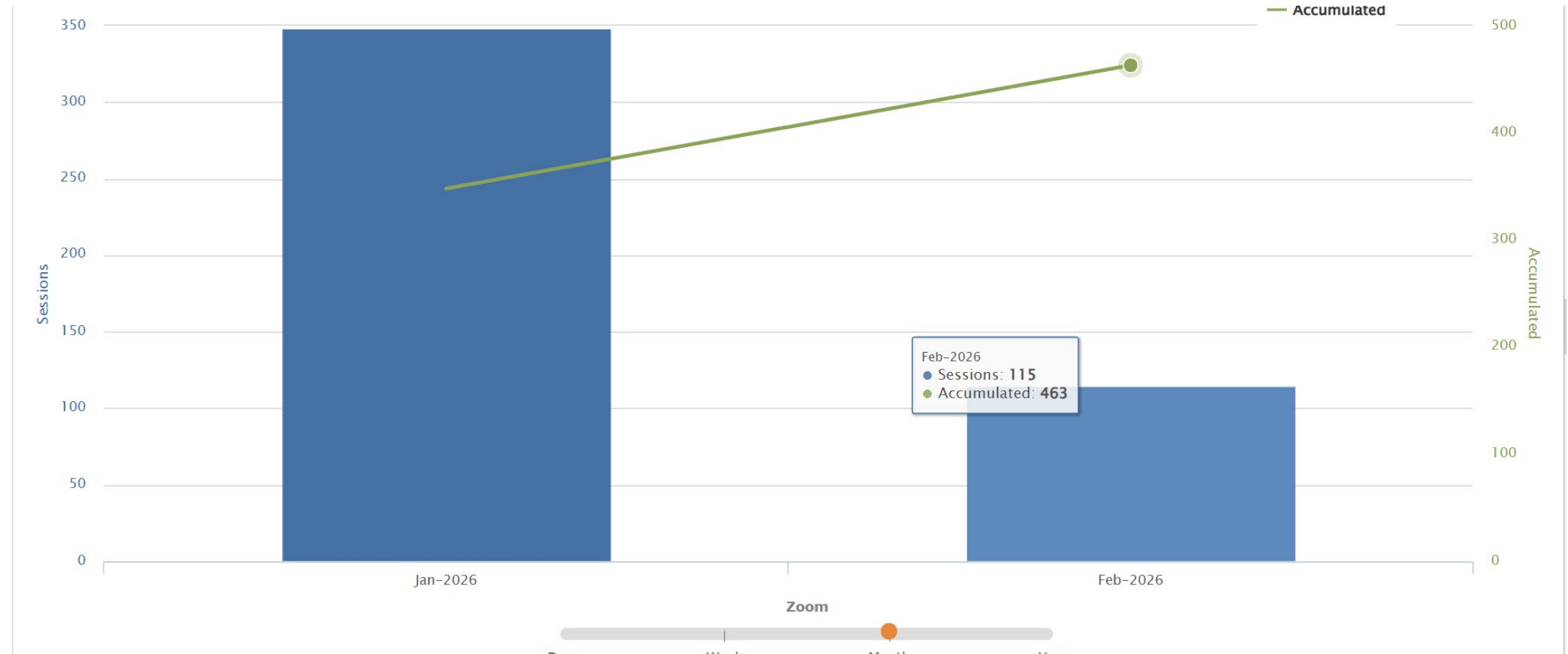

- Expanding EV Charging Infrastructure – Design and procurement underway for two DC Fast Chargers at Mesa Public Library partially funded by an NMDOT Grant

# Environmental Sustainability Board

- Environmental Sustainability Board is at full capacity
- The board approved the 2026 Work Plan with priority focus on Climate Action Plan Implementation
- Recycling audit showed 17% contamination - a record low compared to state averages
- They also provided a recommendation for B&C Term Limits
- The ESB was asked to provide a Zero Waste Station at the Jemez Mountain Trail Run



# Other Highlights

- Evaluating Extended Producer Responsibility legislation (State-wide initiative)
- Researching Tariff on Bill Financing to support energy efficiency upgrades
- Selected to receive an EPA SWIFR Food Composting Grant for \$1.2M
- Sustainability Newsletter – Engagement rate 75%
