



**AMENDMENT NO. 2
INCORPORATED COUNTY OF LOS ALAMOS
SERVICES AGREEMENT NO. 25-963**

This **AMENDMENT NO. 2** ("Amendment NO. 2") is entered into by and between the **Incorporated County of Los Alamos**, an incorporated county of the State of New Mexico ("County"), and **Stryker Sales, LLC**, a Michigan limited liability company ("Contractor"), to be effective for all purposes June 10, 2026.

WHEREAS, County and Contractor entered into Agreement No. AGR25-963 dated July 9, 2025, recorded with the County Clerk's Office as Document No. LACF25-1115, and Amendment No. 1, dated January 28, 2026 (as amended the "Agreement") for LifePak35 systems (the "Devices"), supporting software and support services (the "Services"); and

WHEREAS, the County seeks to purchase additional LifePak 35 systems, supporting software and support services; and

WHEREAS, both parties wish to amend the compensation to allow for purchase of additional Devices and Services under the terms of the Agreement; and

WHEREAS, the County Council approved this Amendment NO. 2 at a public meeting held on June 9, 2026.

NOW, THEREFORE, for good and valuable consideration, County and Contractor agree as follows:

- I. Delete Paragraph 21 in its entirety and replace with the following:

21. Compensation: Amount of Compensation. County shall pay compensation for performance of the Services over the life of the Agreement in an amount not to exceed ONE MILLION TWO HUNDRED ONE THOUSAND ONE HUNDRED EIGHTY-SIX AND 57/100 DOLLARS (\$1,201,186.57) as detailed in Quotation 10948802, Quotation 11182577, and Quotation 11300102, which amount does not include applicable New Mexico gross receipts taxes ("NMGRT").

- II. Delete **Appendix 6, Devices and Services Schedule**, in its entirety and replace with a modified Appendix 6, as attached below.

Except as expressly modified by this Amendment, the terms and conditions of the Agreement remain unchanged and in effect.
