Report by Jessica Strong, Los Alamos County Social Services Manager

Jessica Strong provided a update during the Health Council meeting, covering recent developments, initiatives, and upcoming events. The following items were discussed:

In Memoriam: Jen Bartram

Jessica began her report by acknowledging the passing of former Health Council member Jen Bartram, recognizing her valuable contributions to community health. A celebration of life event will be held in her honor, with details to be shared with Council members and the public.

Suicide Prevention Initiative

The County has launched a suicide prevention initiative aimed at addressing mental health concerns in the community.

The first training session under this initiative has been successfully held, with additional sessions planned.

This effort includes collaboration with local stakeholders and focuses on building awareness and response capacity.

Media Contributions and Outreach

Jessica highlighted recent contributions by staff and Health Council members through:

Newspaper articles

Radio and media appearances

Other public outreach efforts aimed at promoting health education and services.

Upcoming Events and Health Council Involvement

Annual Flu Clinic: Scheduled at Los Alamos Medical Center. There is potential for a Health Council presence to distribute information and promote local health initiatives.

Recovery-Related Event: Planned for September, tied to National Recovery Month.

Mental Health Awareness Events: Scheduled for October, aligning with national awareness campaigns.

Staffing Updates

Lori Padilla has been hired for the new part-time Mobile Outreach position.

A Program Specialist position will be opening soon to further support social services and community outreach initiatives.

Statewide Conference in Portales

Jessica shared insights from her participation in a statewide social services conference in Portales.

Key topics included:

Interstate compact support for service coordination across state lines.

Networking and sharing of best practices across counties.

Sequential Intercept Mapping (SIM) Convening

A Sequential Intercept Mapping session was recently held in the County Council

chambers.

This mapping initiative focuses on the intersection of behavioral health and the criminal justice system.

The goal is to improve services, reduce recidivism, and support individuals with mental health or substance use challenges through strategic interventions at multiple intercept points.

Regional Behavioral Health Development

Jessica discussed the state's allocation of \$100 million for regional behavioral health development.

Planning is underway to leverage these funds for infrastructure, services, and collaborative supports across the region.
