LOS ALAMOS

INTRODUCTION

The County Manager's Monthly Report provides updates on key programs and projects, County financials and metrics that help track how the staff are serving the community.

NOTE FROM THE COUNTY MANAGER

November activities brought the start of the holiday season with outdoor temperatures feeling like winter is on the horizon and we just might start getting some snow. For the County that means readying our plows, stocking our snow removal and melting supplies, and reminding everyone what our response process is when the snow flies.

Council only has two meetings in November due to the Thanksgiving Holiday, however their meeting agendas were full and had many important discussions and actions taken including:

- Proclamations for Operation Green Light for Veterans, Small Business Saturday, and Giving Tuesday
- Appointments to the Health Council and Parks and Recreation Board
- Award of the 4th of July entertainment 7-year contract
- Adoption of the Guaje Pines Cemetery Master Plan
- Adoption of Council's 2026 Strategic Leadership Plan
- Recognition of the Los Alamos County Election Officials
- Approval of a five-year service agreement for implementation and technical support for a new dispatch system for handling 911 emergency calls
- Approval of an ordinance to sell bonds related to the Community Broadband Network project implementation
- Approval of water tower space to mount a new AT&T communication antenna on North Mesa
- Approval of a land lease for a new Verizon communications tower within Overlook Park
- Presentation and acceptance of the Artificial Turf and Site Improvements feasibility study for the County's recreational fields
- Presentation on lessons learned on recent joint road and utility projects and their effects on businesses and residents
- Approval of Fiscal Year 2027 budget guidance
- Approval of service agreement amendment for Inspection of Public Records related services
- Discussion about increasing elected official's salaries (only effective after next election cycle)

Some of my November activities as county manager included:

- November 3rd, provided a welcome to Los Alamos for the State of NM Transportation and Infrastructure Interim Committee and an overview of the County's budget, structure, initiatives and needs such as middle-mile fiber connections, NM SR 4 rebuild and multi-modal improvements
- November 6th, attended the Chamber breakfast where tax consultant discussed Gross Receipts Tax (GRT), the State of NM tax laws, and its pros and cons
- November 6th, attended the NM Counties Managers Retreat in Santa Fe with topics of discussion including regional juvenile detention facilities, insurance pool coverage options, NMDOT right-of-way maintenance responsibilities, and District Courts behavioral health efforts
- November 10th, attended the LACDC board meeting and discussed their preference for being an advocate and support for businesses applying to the County for LEDA projects rather than a third-party reviewer of applications in preparation of Council consideration
- November 11th, attended the Veteran's Day ceremony at Ashley Pond
- November 12th, met with a concerned resident about the voting day line and construction barriers at the Municipal Building
- November 13th, Fire Chief interviews held with the top four candidates and facilitated a candidate meet and greet with fire staff
- November 17th, participated in a discussion with new federal lobbyist and our federal legal counsel
- November 19th, Human Resources Manager interviews held
- November 20th, attended joint County, LAPS and UNM-LA leadership monthly luncheon and discussed the North Mesa housing project next steps with LAPS to consider support of moving forward and an updated MOU with the County outlining next steps
- November 21st, met with top two fire chief candidates
- November 21st, attending the Los Alamos MainStreet accreditation concluding meeting with re-accreditation achieved
- November 25th, coordination meeting regarding the UbiQD LEDA request
- November 25th, phone call with MariMac owner/developer and received a verbal update that they are still working on a County financial participation request for their project with the specific details of feasibility/legality remain undisclosed to the County

Council's approval of the Community Broadband (CBN) project and the anticipated sales of revenue bonds in February 2026, the County moves forward an important economic development priority that has been contemplated for decades. The project will provide access to high speed and quality internet services to every resident and business at a competitive cost. This initiative also will connect to a second "fiber off the hill" line and offers improved redundancy of service from what is available now.

INTERGOVERNMENTAL, TRIBAL, AND REGIONAL RELATIONS

State

At the Infrastructure Finance Conference, address the issue of timing of the ICIP submissions to the State and other new requirements that are becoming increasingly difficult for local governments to meet.

Worked with the Regional and State Working Group to finalize the County's State Policy Agenda for 2026.

Federal

Two deep dives with the new federal lobbyist team were held to ensure coordination and understanding of Los Alamos County issues.

Working with Congressional Delegation on two issues – the FEMA grant for the Jemez Mountain project and language in the Energy and Water Bill.

Attended the National League of Cities (NLC) City Summit in Salt Lake City. The policy item to support a grant program for DOE communities was passed by the full membership for another year of support. Additionally, finalized preparation for a new affiliate group for Intergovernmental Professionals within NLC.

Tribal and Regional

Continued to work with neighboring communities. Guidelines for the Regional Strategic Partnership Fund will be brought to Council early next year.

FISCAL STEWARDSHIP

Financial Overview

The Finance team continued wrapping up the annual financial statements and year end audit. Budget kicked off department guidance for FY27 with a general message to keep as close to flat as possible, while maintaining contractual and personnel growth, and looking to cut at least 10% in non-labor, non-contractual expenditure categories as the team begins budget development. Although the team experienced a much higher than average Gross Receipts Tax distribution in November, much of this is attributed to the fiscal year end spending of LANL. Gross Receipts Tax projections still bear some uncertainty as the team develops the FY27 budget.

Update

Overview of the 2025 Regular Local Election Administration

The Los Alamos County Clerk's Office administered the 2025 Regular Local Election in accordance with all applicable state statutes and established election procedures. Early voting was conducted from October 7th through November 1st at the Los Alamos County Municipal Building and the White Rock Town Hall, providing voters with consistent and accessible opportunities to participate prior to Election Day.

On Election Day (November 4th), five Vote Centers were operational throughout Los Alamos and White Rock. All locations were staffed, equipped, and monitored to ensure compliance with voting system requirements and to support a smooth voting experience for all eligible electors. Absentee ballots were issued, received, and processed following statutory guidelines, and secure ballot drop boxes were available to further support voter access.

The Clerk's Office oversaw all administrative components of the election, including the maintenance of voter registration records, poll worker training and deployment, chain-of-custody procedures, ballot accounting, and the tabulation and canvassing of returns. The election included contests for the Los Alamos Public Schools Board, the UNM–Los Alamos Advisory Board, and the Mirador Public Improvement District Board.

Following the close of polls, the Office completed its post-election systems check to confirm the accuracy of the voting equipment and to verify that the reported results were consistent with the ballots cast. This verification process reaffirmed the integrity and reliability of the election.

The 2025 Regular Local Election was conducted with an emphasis on accuracy, transparency, and adherence to statutory requirements, reflecting the Clerk's Office's commitment to administering secure and accessible elections for the residents of Los Alamos County.

Connecting with the Public

A Brief Report on November 13th Canvassing Board Meeting

The Los Alamos County Canvassing Board met on November 13, 2025, to complete the county canvass for the 2025 Regular Local Election. The board is responsible for

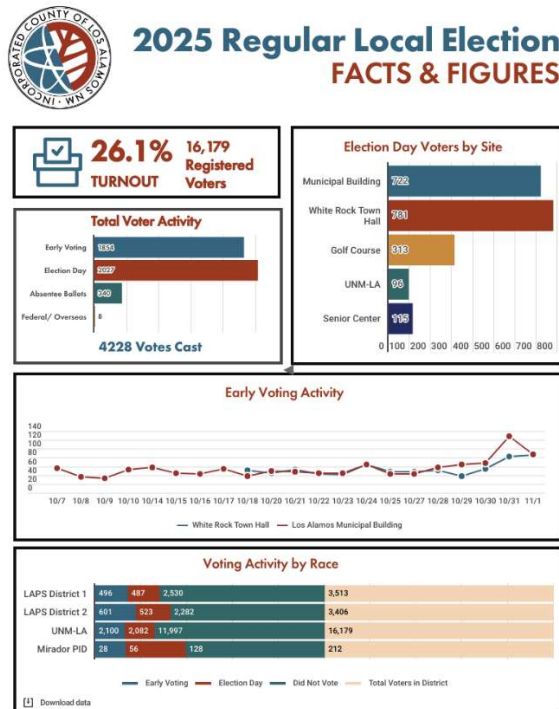
reviewing all election returns, confirming their accuracy, and certifying the official results for the county. This work includes reviewing early voting, absentee voting, Election Day voting at each Vote Center, and any provisional ballots that were adjudicated by the Clerk's Office.

During the meeting, the board examined the documentation prepared by the Clerk's Office and verified that all tabulation procedures were completed in accordance with New Mexico election law. Following this review, the board approved the canvass report and issued the Certificate of Canvass, which serves as the county's official certification of results.

Once the county canvass was complete, the Clerk's Office submitted the certified results to the Secretary of State. The Secretary of State's Office then conducts its own statewide canvass, which involves reviewing and reconciling the results submitted by all counties. After this step, the New Mexico State Canvassing Board meets to approve the statewide canvass for every contest on the ballot. The State Canvassing Board's approval constitutes the final official certification for the entire state.

Fire Chief, due to the retirement of Troy Hughes, Human Resources Manager due to the retirement of Mary Tapia, and Public Information Officer, due to upcoming retirement of Julie Williams Hill.

Bernadette Martinez is acting as the Interim HR Manager until the vacancy is filled.

The staff are recruiting an HR Analyst 2 within the Training area.

Currently, the staff is also preparing for the upcoming FY27 Budget meetings.

Training Stats:

Risk and Safety hosted an "Asbestos Contractor Supervisor" Training for Electrical Distribution, GWS, Water Production, DPU Engineering, and Facilities Supervisors and Staff. Thank you to DC Environmental for bringing this training to Los Alamos County. There will be another class in March for staff that were not able to attend. Infrastructure Update

Phase 6, the final phase of the .gov email migration project, has been successfully completed. As of December 1, all users within LAFD and LAPD have migrated to the losalamosnm.gov email domain. This marks the completion of the organization-wide migration effort. Thank you to everyone involved for your support and cooperation throughout this process.

New GIS Base Station installed (Mesa Library) provides for

- Substantially higher accuracy for county surveyors and locations of county-owned assets
- Greater security
- Support for new international constellations like Galileo (ESA) and BeiDou (CNSA) and newer satellites in the existing GNSS (NASA) and GLONASS (RSF)
- Used by LANL

Application Update

- Applied software updates and successfully upgraded the Assessor's Property Tax Assessment system to version 2025.1.19.
- Enhanced the "What's Around Me" map on the Public Website by adding icons for Parks. Discussions are also underway to include Narcan locations and cooling areas in future updates.
- Resolved GPS-related issues and enabled Automatic Vehicle Location (AVL) integration on 40+ imaged F110 Getac devices for LAFD.

- Successfully conducted Zerto failover testing from the Muni site to the ABQ DR site for the database server used by various County departments. This ensures continuity of operations from the DR site in the event of disruption at the Muni site.
- Supported LAPD with the technical evaluation of a new personnel background screening service.

AIRPORT

Take-offs and Landings – November continued the trend of favorable flying weather at the Los Alamos County Airport, resulting in solid operational activity throughout the month. A total of 338 aircraft operations were recorded, consisting of 129 based aircraft operations and 209 visiting operations (per Virtower data). Classic Air Medical helicopter activity remained steady at about 110 operations

Updates

On October 31, the Los Alamos Fire Department took delivery of the salvaged Jetstream 31 aircraft, which has now been positioned on the west ramp for regional Aircraft Rescue and Fire Fighting training. The goal of the project is to provide firefighters with hands-on experience practicing aircraft extrication, emergency response coordination, and fire-suppression techniques on a full-size airframe. This platform also supports multi-agency drills and improves preparedness for real-world aviation incidents.



Inside the terminal, assembly of the newly redesigned kitchen is underway, following the removal of the original cabinetry in October. The Airport Manager is also preparing snow-removal equipment for winter operations and coordinating with the Traffic & Streets Division to ensure airfield surfaces, access roads, and lighting infrastructure are ready for seasonal conditions. Behind the scenes, work continues both on the Taxiway-F Relocation Project design effort and construction of the T-Hangar Project.

Looking ahead, the Airport is partnering with Experimental Aircraft Association (EAA) Chapter 691 to host the third annual Santa Fly-In on Saturday, December 20, bringing a holiday aviation event to local families and continuing a growing community tradition.

Fire Staton No. 4 Replacement: Design development for the FS 4 replacement is in progress with the design team actively reviewing design plans and documents.

Ice Rink Chiller: The new Ice Rink chiller is operational and was handed over to Ice Rink staff on November 13 to begin ice making operations. The Ice Rink was open to the public on November 28, 2025.



Municipal Building EV Chargers: Installation of new EV chargers at the Muni Building continues. The contractor completed the flatwork and is currently working on charger installations and landscaping restoration.



Asset Managing: AkitaBox, the new facility asset management and work order software, is up and running. The team is currently transitioning all workflows into the new system and collaborating with account representatives to resolve a few remaining issues.

Los Alamos Little Theatre: The installation of the fire suppression system at the Los Alamos Little Theatre is complete. The contractor is finalizing punch list items. In addition to this work, thermal insulation on the roof deck and new led lighting were installed throughout the building. Capital Projects and Facilities staff also replaced the existing gas fired water heaters with a single electric hot water heater.

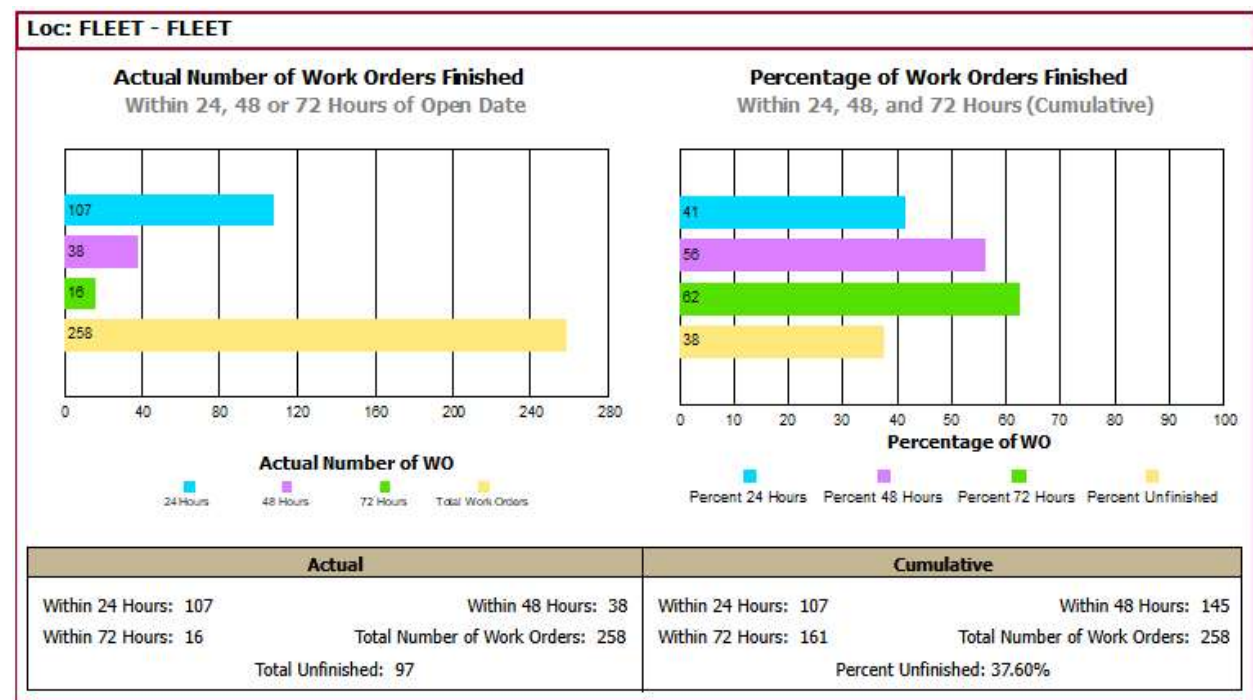

November Operations Report

The **Signs and Markings Crew** completed final layout and striping work on San Ildefonso and North Mesa Road following the recent asphalt improvements. The team also striped the new island configuration on Camino Entrada, including all required symbols and legends. Crosswalks on Central Avenue were repainted, and striping for the Little Theater parking lot was finished. In addition, the crew fabricated and installed approximately 15 new signs, including an Adopt-A-Road sign on North Mesa Park Road, and addressed several sign knockdowns throughout the area.



Signs and Markings crew striped paved sections on San Ildefonso Road and Camino Entrada.

The **Traffic Division** conducted traffic counts at three key locations on State Road 4 in White Rock. The team replaced a damaged traffic mirror at the intersection of Rose Street and Circle Drive. The team also repaired a streetlight pole equipped with cameras and communication equipment at NM 502 and Airport Drive after it was struck by a vehicle.

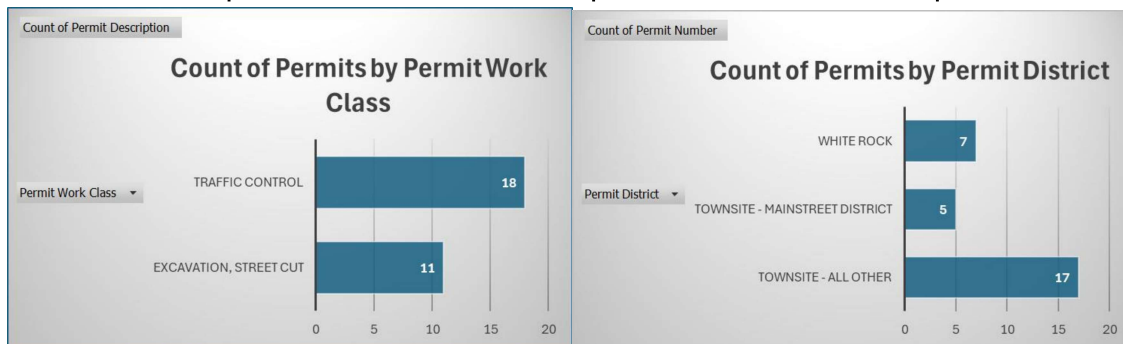
The **Streets Crew** excavated, prepared, and paved the intersection at Cheryl and Aragon Avenues. Crews performed potholing on Rendija Canyon Road, Orange Street, and other locations across the county. Additional work included tree trimming on Alamo Drive, repairing an eroded culvert on 33rd Street, replacing a concrete gutter at 2306 Canyon Glen, and repairing a damaged culvert on 35th Street. The crew also assisted with traffic control for the Trick-or-Treat on MainStreet event, helped set up snow-removal equipment for the event to showcase the snow removal operations, and participated in handing out candy.

In preparation for winter operations, crews provided snow-removal training and completed maintenance on snow-removal equipment. The team also trimmed trees and brush along State Road 4 at Mirador Boulevard to improve sight distance. At the ice rink, crews drilled holes around a junction box for future bollard installation. Additionally, paving work was completed at the White Rock tennis courts.



Streets crews excavated, prepared and laid asphalt and repaired a culvert that eroded at the intersection of Aragon and Cheryl Avenues.

Administrative staff processed and issued 29 permits and extended 2 permits.

Updates

Affordable Housing Service Providers: The Housing Trust continues to market its programs at various events throughout the community and currently have multiple applications in process for both the Home Rehabilitation and Homebuyers Assistance programs. [Goals: Housing.]

North Mesa Update: Wilson and Company has finalized the North Mesa Transportation and Utilities Study. The final report provides preliminary designs and cost estimates for the system upgrades needed to serve the site with utilities and to mitigate the project's impact on the transportation system. [Goals: Housing, Intergovernmental Relations.]

A-8-A: The effective date for the Sales, Purchase, and Development Agreement for the A-8-A property is November 14, 2025. This key date kicks off the due diligence phase of the development process. The due diligence period is expected to take until early next year. During this phase county staff will provide the development team with key documents including previous engineering, soils, planning reports, and similar documents for review. The Title Report and ALTA Survey for the property are expected to complete the week of December 1, 2025. The development partner is currently surveying the site and have started geotechnical boring and analysis.

The development proposal includes a total of 380 units comprised of 1-, 2-, and 3-bedroom units. 120 units will be permanently deed restricted for households earning between 60%-100% Area Median Income (AMI) with an average of 80% AMI. The goal of the project is flexible income eligibility with low rent requirements, not exceeding 30% AMI of income for market rate units. [Goals: Housing.]

LOCAL BUSINESS

LEDA Retail Program

The LEDA Retail Program supports expansion, retention, and recruitment of local retailers that fill service gaps, strengthen the tax base, and improve livability. Staff finalized all core materials including a Handbook, Screening Questionnaire, Application Packet, and outreach tools to support program rollout.

Current Activity Snapshot:

- 19 Screening Questionnaires received; all applicants met with staff and were notified of status.
- ~1/3 not approved due to ineligible retail activity and/or insufficient economic benefit.
- ~1/3 advanced to Part Two; only Yuan's Dumpling & Noodle House submitted a complete packet.
- Yuan's PPA + Security Agreement in development; ordinance expected to Council in early January.
- Remaining applicants: eligible retailers but insufficient economic benefit. Staff assisting them with revisions. Staff has been informed two additional applicants are actively working on revising their proposal and staff anticipates receiving at least one more formal application by year's end.

Countywide LEDA Program

LEDA remains a key economic development tool for business expansion, retention, and relocation—supporting PPAs, eligibility review, and accountability for public benefits such as jobs and investment.

After initial delays, launch is expected January 2026.

COMMUNITY BROADBAND

County staff, including the broadband manager, continue to meet weekly with vendor Bonfire on “Low Level Design” work for the Community Broadband Network (CBN) project. The Bonfire team has the first construction permit package ready to submit to the county for review and approval. Additional key items from Bonfire’s design work include future CBN (Community Broadband Network) web portal design, plans to attend the upcoming statewide broadband summit which will also be attended by LAC staff, presentation of the most current updates to the project’s cost worksheet.

Another countywide internet outage occurred on 11/11 due to a fiber cut near 599 in Santa Fe. The broadband manager participated in a community Zoom meeting hosted by LA NET which discussed the outage impact and what can be done to address these types of disruptive events.

The San Ildefonso Pueblo middle mile fiber project continues to make good progress. Crews continued working on the section going east from the Rio Grande River bridge

towards the Pojoaque border. Progress includes work on Pueblo's new cell towers, specifically for the tower near the Totavi store. Some portions of the tower itself are now in place and can be seen when driving by on NM502. Staff for the Pueblo project indicate that the 11-mile fiber project should be completed in two months.

At the 11/18 council meeting, council approved the \$40M bond purchase, to be used primarily to fund the CBN construction. The broadband manager provided a report during this item to give a history and timeline for broadband improvement efforts, as well as additional context related to the plans for and features of the CBN, as well as touching on the 11/11 outage.

Updates

Social Services continued to assist clients in November, with the majority of new and recurring clients seeking help securing housing, income support services, and needing assistance with food and other emergency basic needs.

Social Services staff and Los Alamos County Health Council volunteers coordinated a massive county-wide effort to connect with people who needed emergency food assistance due to the federal government shutdown and suspension of SNAP benefits. The staff was able to set up multiple distribution spots at Los Alamos and White Rock businesses with the help of the Chamber of Commerce & Main Street Creative District, and multiple distribution points, including both library locations, JJAB, and the Justice Center. To date, over 200 emergency food bags have been collected and distributed (which runs through December!)

Social Services Manager Jessica Strong attended several planning sessions related to implementing regional behavioral health initiatives under Senate Bill 3 / Behavioral Health Reform and Investment Act (BHRIA).

Work is continuing on the county-wide Sequential Intercept Model, as well as regionally on addressing behavioral health needs with Senate Bill 3.

Finally, staff member Deni Fell attended the 2025 National Organization for Human Services (NOHS) conference, Empowering Change through Compassionate Action, November 7-9 in Charlotte, NC.

The Breathing Association's Nicotine Treatment Specialist Training - November 2025

Updates

AGR24-950, OpenGov Asset Management Software for the Parks and Open Space Division, is utilizing the system in White Rock. The system tracks work tasks across the landscape. It was anticipated for implementation in Los Alamos in August; the team is behind and anticipates rolling this out in September and October. The goal is for the team to be operational in all areas by December 31, 2025.

RFP25-37, Guaje Pines Cemetery Master Plan process kicked off in March 2025.

The contractor, Sloane Consulting Group, will be conducting a site visit on March 26-27, 2025, for data collection and staff discussions. A community survey closed on May 30, seeking community feedback. Three public engagement meetings were held with community members. A presentation of the Master Plan was given to the Parks and

Recreation Board on September 11, 2025, with the board's support and approval. The plan will be introduced on October 28, 2025, and approved on November 4, 2025, County Council Meeting, 7-0.

IFB28-18 - Athletic Field Renovations approved by County Council on 11/19/24.

This is a three-year sports field renovation plan to address field leveling/laser grading, replacement of sod, and irrigation adjustments. The work will begin on May 23, 2025. Contractor was issued a job order with the ability to proceed on May 19, 2025, for staging and field renovation to begin May 23, 2025. The project is underway at all locations with a substantial completion date of August 31, 2025. This timeline was not achieved, and the department is working with the vendor on ways to complete the contract as written.

AGR24-23, Site Southwest Open Space and Trails Management plan is in the final stages. The contractor has conducted multiple community engagement meetings and is working on final reviews and edits of the plan. The plan was presented to the Parks and Recreation Advisory Board on August 14 for support and approval. A few edits were requested and made. The plan will be on the September agenda for the Parks and Recreation Board meeting for review, no action required. The plan was presented and approved by the County Council on October 28, 2025.

The 37th Street and Pinon Playground renovations were identified as needing improvements to meet Americans with Disabilities Act accessibility requirements and were based on the Community Services Department's Integrated Master Plan. The renovation will improve safety, access, and update amenities. Through IFB#25-55, LA Landscape and More, LLC was awarded the contract in the amount of \$2,218,882 (including a 5% contingency). Removal of the old playground equipment has been completed at both sites. Construction will continue as weather allows, with a completion date of April 30, 2026.

Updates

EMS Division - EMS Protocol Review and Updates

The Fire Department staff collaborated closely with the Medical Director, Dr. Chris Hammond, on the annual EMS protocol review. These protocols guide patient care and treatment across a wide range of medical and trauma emergencies. Throughout October, LAFD field providers were invited to submit feedback through an internal survey. All input was reviewed with Dr. Hammond, and appropriate updates are now being integrated. The revised protocols are scheduled for full launch in January 2026.

LifePak 35 Implementation

The Division continued the phased rollout of the new LifePak 35 cardiac monitors. The LifePak 35 is a modern, multifunction cardiac monitor/defibrillator designed to provide advanced cardiac assessment, real-time vital sign monitoring, 12-lead ECG acquisition, and resuscitation support. This month's work included equipment preparation,

configuration, and comprehensive training for EMS personnel to ensure familiarity and proficiency with this new technology.

AHA Instructor & CPR Quality Initiatives

The team hosted an American Heart Association (AHA) instructor course for LAFD members and community healthcare providers. Training included CPR, BLS, ACLS, and PALS disciplines. This initiative supports the mission to strengthen the department's high-quality CPR program and promote community-wide awareness and recognition of lifesaving CPR practices.

CPSE Accreditation Preparation

The EMS Division continued internal preparation for the Center for Public Safety Excellence (CPSE) accreditation process. Work this month focused on documentation review, program assessment, and aligning EMS operations with accreditation standards.

Technical Rescue Team (TRT)

On November 21, 2025, Los Alamos Fire Department Technical Rescue Team (TRT) conducted vehicle-extraction training at Fire Station 2. This hands-on skills session is part of LAFD's ongoing commitment to maintaining advanced rescue capabilities for complex emergency situations, including motor-vehicle crashes, entrapments, and multi-hazard incidents.

The training focused on modern extrication techniques using current-generation stabilization tools, hydraulic rescue systems, and safety procedures designed to address the evolving construction and safety features of newer vehicles. Crews practiced coordinated team approaches to accessing and removing simulated patients while maintaining scene safety and minimizing additional injury.

Station 2 provides an ideal environment for controlled, realistic training, allowing firefighters to refine technical skills while strengthening communication and teamwork. Regular TRT exercises ensure that personnel remain proficient, adaptable, and ready to respond efficiently when seconds matter.

This training underscores LAFD's dedication to professional development, operational excellence, and providing the highest level of rescue services to the community.



Public Education Events

Throughout November, the Los Alamos Fire Department's Fire Marshal's Office (FMO) continued its commitment to community risk reduction and youth fire-safety education by conducting several outreach events at local and regional schools. These activities supported LAFD's mission to promote early fire-safety awareness, strengthen community partnerships, and engage students of all ages in understanding fire prevention and emergency preparedness.

Mountain Elementary Pre-K Presentation – November 6, 2025

FMO personnel visited Mountain Elementary School to provide a fire-safety introduction for 45 Pre-K students, ages four and five. The presentation focused on recognizing firefighters as helpers, understanding smoke alarm sounds, and practicing basic safety habits such as "Stop, Drop, and Roll." Students were also able to explore fire-safety equipment and ask questions, helping build confidence and familiarity with emergency responders.

Pojoaque Valley High School Health Fair – November 7, 2025

LAFD participated in the annual Pojoaque Valley High School Health Fair, engaging with an estimated 50–100 high school students and approximately 50 adults. FMO staff provided information on home fire-safety practices, teen driver emergency awareness, careers in the fire service, and Wildland-Urban Interface (WUI) preparedness. The visit supported the fair's health and wellness focus by emphasizing proactive fire prevention and community resilience.

Horizon Academy West School Visit – November 19, 2025

The Fire Marshal's Office conducted a full-school safety visit with 100 kindergarten students and 5 adults at Horizon Academy West. The program introduced young learners to emergency basics, including how to identify hazards, when to call 9-1-1, and what firefighters do during an emergency. Age-appropriate demonstrations and a

guided discussion helped reinforce safety messages while encouraging students to share what they learned at home.

Virtual Station Tour – Station 3 (Pecos Cyber Academy) – November 20, 2025

To expand outreach to remote learners, LAFD hosted a virtual tour of Station 3 for 68 first-grade students from Pecos Cyber Academy. Firefighters led a live, interactive walkthrough of the station, apparatus bay, and fire engines while explaining core responsibilities such as emergency medical response, fire suppression, and community assistance.

LAFD Fire Chief Interviews

During the month of November, the Los Alamos Fire Department (LAFD), in collaboration with the County Manager's Office, conducted a series of interviews as part of the selection process for the department's next Fire Chief. This effort is a critical step in ensuring continuity of leadership and maintaining the high operational standards expected by the community.

The interview panel included County leadership and senior LAFD representatives who evaluated candidates on strategic vision, experience in emergency services management, ability to lead a diverse and highly skilled workforce, and commitment to community engagement and fire-service excellence. Emphasis was placed on identifying a leader capable of guiding the department through continued growth, modernization, and long-term planning.

This collaborative and thorough process reflects Los Alamos County's dedication to selecting a Fire Chief who will uphold the department's strong tradition of service while fostering innovation, resilience, and professional development within the organization.

ENVIRONMENTAL STEWARDSHIP

This month brought exciting progress across several sustainability initiatives:

Holiday Tree Ornaments Made from Recycled Materials

Los Alamos Public Schools, PEEC Nature Center, Citizen Climate Lobby, and County employees teamed up to create stunning handcrafted ornaments for this year's holiday tree. Made from pine cones, repurposed aluminum tray pans, discarded paper, and paperboard, these ornaments showcase how everyday "trash" can be transformed into festive treasure. Stay tuned for the final reveal!

Draft Fleet Conversion Plan & Community-Wide EV Charging Plan Delivered

Stantec delivered the draft Fleet Conversion Plan and Community-Wide EV Charging Plan. The internal committee reviewed and submitted revisions, and both draft plans will be presented to the County Council, Board of Public Utilities, and Environmental Sustainability Board in December. Preparations are also underway for a community meeting to share the draft plans and gather public feedback.

Launch of the Green Los Alamos Certification Program

The Green Los Alamos Certification Program—designed to recognize local businesses for environmental stewardship—was finalized and presented to County Manager Anne Laurent, who approved the program. The Environmental Sustainability Board also expressed strong support.

Staff Induction Stove Popcorn Party

In collaboration with Abbey Hayward, staff enjoyed a popcorn party to highlight the new induction stove technology available for exploration and use. This hands-on demonstration supported energy-efficient cooking awareness across departments.

Environmental Sustainability Board Updates

The ESB met to begin drafting its 2026 Work Plan, voiced support for the Green Los Alamos Certification Program, and received a recap of the New Mexico Recycling Conference presented by Angelica Gurule.

Progress on EV Charging Infrastructure

Staff continued implementation of the Level 2 EV charging project at the Municipal Building, which remains on schedule for completion by December 31, 2025. Work is also underway on the design of the new DC fast charger planned for Mesa Public Library.

Update

As part of the "Operation Save the Bears" initiative, Environmental Services delivered 260 dumpsters to the business community and 1,000 roll carts to residential customers during the first wave of the program. In December 2024, Environmental Services received an additional 1,154 Kodiak Bear-Resistant Carts and has since distributed more than 1,100 to residents that requested one.

Bears are fattening up for hibernation, and there has been an increasing number of reports about trash carts being raided. To help prevent wildlife encounters and keep the neighborhoods safe, residents are encouraged to consider using bear-resistant trash carts. If you're interested in requesting one, please visit www.losalamosnm.us/gogreen to submit a request.

Yard-trimming collection in Los Alamos is coming to an end for the season. As winter approaches, the Environmental Services Division is reminding residents that curbside pickup of yard waste will pause after the final scheduled collection the week of December 1, 2025. During this seasonal break, no brown-cart, yard-trimming pickups will occur. Residents are encouraged to hold material until service resumes next spring, compost when possible, or take yard debris to the Eco Station during regular hours. With one more collection to go, Environmental Services collected a total of 941 tons of yard material at the curb in 2025.

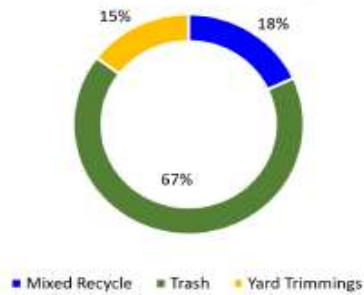

Monthly Collection Report

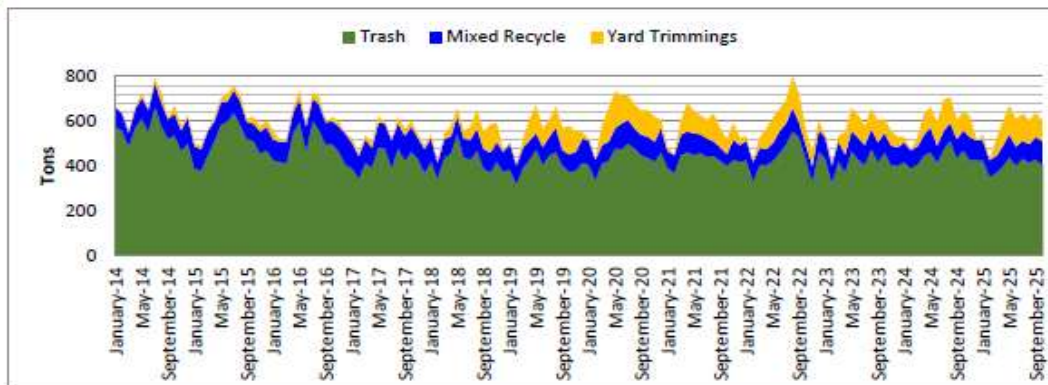

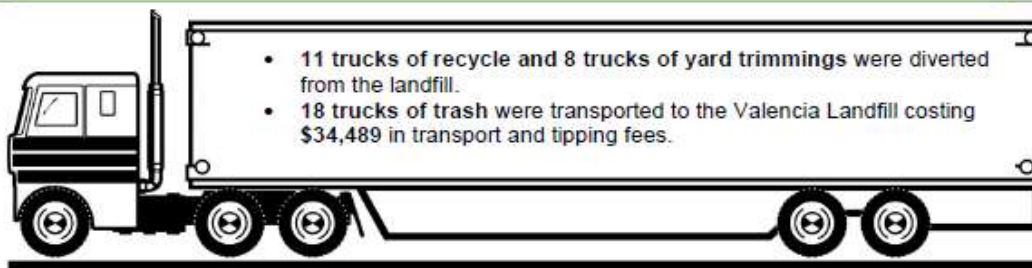

Capital Improvement Projects Updates – Engineering

Los Alamos County is working on a variety of projects that support quality of life, infrastructure, and economic development initiatives. A summary of the project and additional information can be found on the website– <https://lacnm.com/PW-Projects>.

NM-4 Crossing and Multi-Use Trail and Pinon Elementary School Trail Extension	PW	This project will create an at-grade crossing of NM State Road 4 in White Rock at the Mirador Subdivision and provide both new multi-use trail infrastructure and reconstructed trail infrastructure in the Pinon Park area. The county received design and construction grant funding from NMDOT for this project. A separate grant was also received to extend the trail network through the Pinon Elementary School to Grand Canyon Drive. The designs are being completed by Bohannon Huston and will be advertised for construction early next year with construction continuing through 2026.
Trinity Drive Safety and ADA	PW	This project is the result of a 2016 road safety audit and has been awarded grant funding from the Federal Highway Safety Improvement Program by NMDOT. A resolution of support was made by Council in September 2024 approving a Hybrid Road Diet, one of the alternatives presented by the engineer Wilson and Co. The design has been finalized with construction anticipated to begin in 2026.
Finch Street	PW	This project design was completed by an on-call engineering firm. The project is anticipated to be advertised for bids in late 2025. Council approved an agreement with the Los Alamos Medical Center for the transfer of land for the construction of the Finch Street project in August 2023. Construction is anticipated to begin in 2026.

Canyon Rim Trail Phase III	PW	The project design and right-of-way (ROW) acquisitions are underway from Knecht Street to 15 th Street. The design is being completed by an on-call engineering firm, Wilson and Co. The project is anticipated to be advertised for bids in Fall 2026 with construction occurring in late 2026/2027. Completion of the trail design from 15 th Street to 20 th Street is pending ROW acquisitions.
Denver Steels Phase II	PW	This project was awarded to TLC Plumbing and Utility (Spear D). The joint project with the Department of Public Utilities includes full road reconstruction along with utility upgrades. The project is anticipated to begin construction in spring 2026.
Fairway Dr. – Trinity Dr. to LANL Gate	PW	This project is a joint-utility project with DPU and is anticipated for construction in late 2026 through 2027. The design is being completed in-house and is underway.

ROADS

The Engineering Division actively manages numerous design, construction, maintenance, and development review projects aligned with the County Council's strategic priorities for infrastructure, mobility, and economic vitality.

Staff have been assisting with the review and inspection of the Hills Apartments, a multi-year development that received certificates of occupancy for two phases in October and November.

Staff presented the Pinon School Trail to the Transportation Board in November. This project is complementary to the NM-4 Crossing and Multi-Use Trail project and will provide trail connectivity from that project through school property to Grand Canyon Drive in White Rock.

Staff will be presenting two important projects to Council in December and January: 1.) The Trinity Drive Safety and ADA project will be presented to Council on December 2 to execute a maintenance agreement for a new Rectangular Rapid Flashing Beacon (RRFB) that will be installed as part of the project. 2.) In January, a request for approval

of a new HAWK signal installation and maintenance agreement will be presented to council as part of the NM-4 Crossing and Multi-Use Trail project.

Preparation is underway for soliciting bids for several key projects, including the Finch Street project, Trinity Drive Safety and ADA Improvements, and the NM-4 Multi-Use Trail and Crossing.

Design development by staff is underway for two Capital Improvements Projects for Denver Steels Phase III and Fairway Drive. These projects are joint-utility projects and are anticipated to be advertised for bids in 2026 for 2026/2027 construction.

The Engineering Division continues to play an active role in reviewing developer applications, conducting inspections, and approving construction permits and design reviews. Recent reviews have covered a diverse range of projects, such as the Christus Development, A-8-A near DP Road, 20th Street Development, the Guesthouse Hotel (old Hilltop House site), the Women's Dormitory Building, and the Hills Apartments/35th Street Realignment. Other reviews include the Century Bank, Sherwood Rounds off Longview Drive, Arbolada, and the redevelopment of the Motel 6 building.
