Chair Haaser updated the Board on the APP Policies & Guidelines. Discussion was had by the Board. The following possible changes were discussed.

- Library art donation exemption will be left in the policy for now.
- Update on the plague and signs.
- Community Awareness and Allotment Programs not to exceed 10% of budget.
  - update 20 year requirement for art
- Add "The Board Shall..." in the Work Plan language to ensure Policies & Guidelines are addressed in the Work Plan.
- Add (3c) Total Budget used for Community Development and Awareness Programs shall not exceed 10% of the total annual budget.
- Keep exemption for art work in the library and include other divisions that also have art work not under APP management in the language. Discussion was had on the library art.
- APP does not want to assume responsibility for art that they have not formally deliberated on. Councilor Havemann gave comment.

Member Foley moved to send the APP Policy & Guidelines to legal council for review. Member Buckthorpe - 2nd. Approved 4-0. Vice-Chair Stevens left the meeting before the vote.

Golf Course Wall Art Project Discussion
