

GRANT OF ELECTRIC UTILITY EASEMENT

Said easement lies within Lot 9 East Gate Industrial Park No. 2, Los Alamos County, New Mexico, the plat thereof being filed for record in the Office of the County Clerk in Plat Book 5, Page 35, on the 29th Day of April 1986.

ELECTRIC UTILITY EASEMENT

An Electric Utility Easement as shown on Exhibit "A" attached hereto is hereby granted to the Incorporated County of Los Alamos for the purpose of installing, operating and maintaining an electric utility by the County, or any company authorized to be in the County easement, for an electric line, switch, transformer or other similar electric equipment facility, together with the right of ingress and egress, both surface and subsurface, for crews and equipment and including the right to remove any obstruction in the easement which may interfere therewith without liability to the owner or any other party for such removal.

The undersigned owners, their successors and assigns, shall not construct or maintain any improvements, or other obstruction in or on the easement granted by this document, without the express written consent of the Incorporated County of Los Alamos. This grant of easement shall be binding upon the undersigned owners, their successors and assigns.

Grantee agrees that following any installation, excavation, maintenance, repair, or other work, the affected area will be restored by Grantee to as close to original condition as is reasonably practicable, at the expense of Grantee.


